I YOUR COMMITTEE REPORTS:

Urban Design Guidelines

- 1. (2) That the Transportation Advisory Committee (TAC) reviewed and received a communication, dated December 15, 2011, and heard a verbal delegation from J. Yanchula, Manager, Community Planning and Urban Design, and S. Galloway, Urban Designer, with respect to the Urban Design Guidelines. The TAC asked that the following comments be forwarded to Staff, by the required deadline of February 22, 2012, for their consideration with respect to this matter:
- (a) the wording should be revised so that it is clear that it is intended as a guideline and not as a document that would override the Official Plan and the Transportation Master Plan;
- (b) the roadway cross-sections identified in the Urban Design Guidelines do not meet current engineering standards and many of the lane widths would not accommodate the movement of transit vehicles;
- (c) the Urban Design Guidelines should review the proposal to establish onstreet parking along the corridors who's major function is identified as movement for through traffic; and,
- the recognition that each corridor must accommodate underground services and have access to development along the corridor, for services and emergency reasons;

it being noted that the TAC encouraged its Members to further review the Urban Design Guidelines and submit their individual comments to Staff.
