The objective of the stakeholder consultation process is to improve the end product through discussion and education.

Background

The Dingman Creek currently has a "D" rating in the Upper Thames River Conservation Authority's (UTRCA) Report Card for surface water quality and forest cover. The Dingman Creek EA is intended to develop an innovative stormwater servicing strategy to remediate the subwatershed and mitigate the impact of future development on water resources, with consideration for current and potential flooding, erosion concerns, as well as wildlife/aquatic habitat and natural corridor enhancement. The focus of the study will be providing stormwater management solutions to facilitate development within the Urban Growth Boundary for the next 20 years. As such, this is the most important stormwater EA to be completed for the next 15 years in South London.

The Dingman Creek EA will follow a comprehensive, environmentally sound planning process with public and stakeholder participation to balance the requirements of stormwater servicing relative to the natural and built environment. An initial design concept includes creation of a "complete corridor" option to assess the opportunities to convey stormwater, wildlife, and people.
