"Stop as Yield" Law


Implemented in the State of Idaho in 1982 and approximately four Colorado municipalities. Originated in Idaho due to an influx of minor cycling tickets.

"A person operating a bicycle or human-powered vehicle approaching a stop sign shall slow down and, if required for safety, stop before entering the intersection..."

"A person operating a bicycle or human-powered vehicle approaching a steady red traffic control light shall stop before entering the intersection and shall yield to all other traffic..."

Ontario Highway Traffic Act

- Stop signs are governed in Ontario by the provincial Highway Traffic Act which identifies bicycles as a vehicle with the same rights and responsibilities as other vehicles.
- "Every driver or street car operator approaching a stop sign at an intersection shall stop his or her vehicle"
 ("driver" means a person who drives a vehicle on a highway)









Yield as Stop Benefits

- · Bicycle Friendly Policy that can promote cycling
- · Codifies natural behaviour
- Can promote cyclist use of neighbourhood streets with frequent stop signs
- Cyclist accommodation at traffic signals without bike detection



Yield as Stop Concerns

- Limited precedents and data available on safety effects (two studies located).
- CanBike and League of American Bicyclists educate around principles of predictability - safety is improved when cycling like a vehicle. Stop as Yield codifies unpredictability.
- · Could reduce pedestrian safety.
- Could undermine goodwill between road users and expend political capital. Oregon's Bicycle Transportation Alliance, a cycling advocacy group cited animosity and loss of clout after a debate.
- Not a priority with Share the Road and the Ontario Traffic Council. Bike Advocacy Groups seem split. Bike Law Canada, Canadian Automobile Association and Bike Minnesota opposed.
- · Not identified in the Ontario Cycling Strategy.





City Staff Current Direction

- Highway Traffic Act modifications are provincial jurisdiction.
- Provincial laws create consistent expectations and behaviours.
- City staff do not have enough data to inform a position to promote.
- Cycling Master Plan focusses on other priorities such as infrastructure and programs.
- City staff will not be undertaking further research at this time due to resource limitations.



Proposed London Bicycle Friendly Awards Policy

- 1. That following policy be established for the issuance of yearly London Bicycle Friendly Awards:
 - a) One Bicycle Friendly Award be presented once a year, in conjunction with the advisory committee process (to include public submissions) for nominations involving the Mayor's New Year's Honour List. These will be awarded to an exemplary individual or an organization or business that has contributed to making the City of London much more bicycle friendly.
 - b) The Cycling Advisory Committee members be authorized to collect/make nominations and select the recipient to be considered for Bicycle Friendly Awards with endorsement by Council;
 - c) The following criteria be established to qualify for the award, that nominees meet a minimum of three of these criteria:

Individual that:

- Volunteers or participates with local cycling events, bike rides or tours;
- ii) Actively cycles year round in compliance with the Ontario Highway Traffic Act and municipal by-laws;
- iii) Leads by example in demonstrating safe cycling skills; and,
- iv) Publically and proactively promotes the benefits of cycling.

Organization or Business that:

- i) Engages their staff, members, constituents and/or clients to actively commute to work and/or ride recreationally;
- ii) Invests in secure, sheltered, monitored bicycle parking;
- iii) Invests in on-site shower and change facilities;
- iv) Offers employee training in bike safety, repair and maintenance;
- v) Offers support for onsite or community bike events and functions;
- vi) Offers a bicycle-friendly dress code and/or incentives to ride to work; and.
- vii) Uses bicycle friendly services (ie bike couriers, bike trailer deliveries).
- d) On the understanding that:
 - i) Unsuccessful nominations may be resubmitted in future years;
 - ii) Individuals currently serving on the Cycling Advisory Committee are not eligible for consideration; and,
 - Businesses and organizations to be considered include but not be limited to: restaurants, grocery stores, manufacturers, offices, media, small and large retailers, bike stores, tourism operators, malls, boards and departments (ie library board, school boards, government, police) hotels and organizations (ie YMCA, health agencies).
