- EMPI (Enterprise Master Patient Index)

We respect your due diligence to implement the Integrated Assessment Record initiative. However, the adoption of the IAR is required by the South West Local Health Integration Network (LHIN), as well the Ministry of Health and Long-Term Care. Specifically, the Ministry's Performance Improvement and Compliance Branch has mandated that all long-term care homes must provide a set of required Resident Assessment Instrument – Minimum Data Set 2.0 data elements that are contained within the daily,
