"the Advisory Committees BE ENCOURAGED to provide input with respect to the draft Budgets and BE PROACTIVELY ENGAGED to obtain their input"


On January 18, 2016, all Advisory Committees were sent a letter and corresponding worksheet requesting input and feedback for their respective committee(s) on the draft Budget.

On-line Budget Simulator (www.buildabudget.ca)


For the fourth year in a row, Civic Administration has used <u>www.buildabudget.ca</u> as a platform for budget engagement and education. This website provides Londoners with a unique opportunity to learn about the proposed 2016-2019 Multi-Year Budget.

It allows Londoners to enter their assessed property value and get a breakdown of how their property tax dollars are distributed to all the programs and services provided by the City of London.

Londoners can use sliding scales and/or yes/no widgets to showcase what they would like to adjust or support over the next four years.

From January 11, 2016 to February 23, 2016, <u>www.buildabudget.ca</u> has had **600 visitors, with 203 visitors submitting responses.**

I am a Ward 6 resident living in beautiful Orchard Park. I am a proud Londoner of 17 years now, and I've chosen the Forest City to live, work, and raise my family in.

I urge you to take a stand and push to keep the funding for the urban forest management strategy in the budget. Every year we don't plant more trees, means fewer years of growth for our green infrastructure.

Our region has lost MILLIONS of trees due to emerald ash borer as well as climate events and development. We cannot sit back and allow our natural forests and our urban tree canopy to disappear due to our inaction and our hesitancy to fund tree protection and planting.
