

## Tree Planting Strategy & Cross-Municipal Collaboration

- Tree Planting Strategy: draft by June this year
- Ideas for cross-municipal collaboration part of TFAC's mandate
- Research into Green Legacy done as part of MTC
  - Successful
  - Just down the road!



#### **Green Legacy Programme**

- Program fully funded by County (2004) to plant 150,000 trees to celebrate County's 150<sup>th</sup>
- Land sold to the County by resident for in 1946 for \$1 with commitment to environmental use

 Grows 161,000 seedlings and saplings a year for distribution, for free, to area residents (primarily rural)

#### **Green Legacy Programme**

- Also do growing for the CAs (30,000 50,000/year)
- Each municipality gets 5,000 to give to residents
- School children do majority of work: every elementary school student in the County participates in some stage every year
- Green Legacy is 100% funded by the county
- \$650,000 in operating costs, mostly salaries



### **Green Legacy Programme**

- Manager Rob Johnson passionate about sharing methods, information with other interested communities
- Province: voted unanimously to take Green Legacy Programme provincewide by planting 150 million trees, beginning in 2017.
