SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-law (Appendix A) **BE INTRODUCED** at the Municipal Council meeting to be held on April 5, 2016 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

2015-19 STRATEGIC PLAN

The following report supports the Strategic Plan through the strategic focus area of *Strengthening Our Community* by improving safety, traffic operations and residential parking needs in London's neighbourhoods.

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix A) to address traffic safety, operations and parking concerns. The following amendments are proposed:


1. St. Catherine of Siena School

A recent public meeting with the neighbourhood, the Ward Councillor and City staff identified the following safety and traffic operation changes near St. Catherine of Siena School:

- Change the Yield control on Quarrier Road at Pelkey Road to a Stop control;
- Change the 'No Parking Anytime' on Quarrier Road between the school driveway and the school bus parking lot entrance to 'No Stopping Anytime'.

During a review of this request, it was determined that the existing 'No Parking Anytime' zone on Quarrier Road was missing from Schedule 2 (No Parking) of PS-111, which is being corrected at this time.

An amendment is required to Schedule 1 (No Stopping), Schedule 2 (No Parking), Schedule 10 (Stop Signs) and Schedule 11 (Yield Signs) for the above changes.



2. Wortley Road Public School

Staff was requested by the Thames Valley District School Board to review the availability of on-street Designated Parking Spaces on Briscoe Street East at Wortley Road Public School due to parents of disabled children needing the designated space to park to drop-off and pick-up their children at the school. In order to accommodate the request, the existing School Bus Loading Zone and No Stopping zone will need to be adjusted.

An amendment is required to Schedule 1(No Stopping), Schedule 16 (School Bus Loading Zones) and Schedule 27 (Designated Parking Spaces – Disabled Persons) for the above change.

3. No Parking

Due to road construction which included the installation of curb and gutters, it is recommended that 'No Parking Anytime' zones be implemented on both sides of Hamlyn Street from Campbell Street to Wonderland Road South.

Due to safety concerns, it is recommended that 'No Parking Anytime' zones be implemented at the following locations:


- Inside of the curve at #56 Camden Road to #80 Camden Road.
- South side of Baseline Road East west of Wimbledon Court.

An amendment is required to Schedule 2 (No Parking) for the above change.

4. Parking Survey

At the request of local residents, a mail-back survey was sent to the property owners of:

- Heather Crescent (North Leg) from Hale Street to Heather Place, where the majority
 of respondents supported the proposed change to implement a 'No Parking Anytime'
 zone on the north side of Heather Crescent (North Leg);
- Irving Place, where the majority of respondents supported the proposed change to implement a 'No Parking Anytime' zone (south side) and a '2 Hour Limited Parking 8:00 a.m. to 6:00 p.m. Monday to Friday zone (North side), east of Patann Drive;
- Jasmine Drive, where the majority of respondents supported the proposed change to implement a 'No Parking 8:00 a.m. to 9:00 a.m. and 3:00 p.m. to 4:00 p.m. Monday to Friday, September 1st to June 30th' zone on Jasmine Drive;
- McGarrell Drive, where the majority of respondents supported the proposed change to implement a 'No Parking Anytime' zone on the north side of McGarrell Drive from Haycock Place to Faircloth Road; and



 Sorell Road, where the majority of the respondents supported the proposed change to implement a '2 Hour Limited Parking 8:00 a.m. to 6:00 p.m. Monday to Friday' zone on the west side of Sorrel Road from Langton Road to Beckworth Avenue.

An amendment is required to Schedule 2 (No Parking) and Schedule 6) Limited Parking) for the above changes.

5. No Left Turns

Transport Canada, the Canadian Pacific Railway and the City undertook a number of safety improvements to the level railway crossing on St. George Street south of Piccadilly Street. As part of this work, Transport Canada directed that left-turns from Piccadilly Street to St. George Street be prohibited to address sightline concerns, railway crossing protection device visibility and to prevent vehicles from driving behind an activated railway gate.

An amendment is required to Schedule 8 (Prohibited Turns) for the above change.

6. Regulatory Signs

Due to safety concerns, it is proposed to change the Yield Signs to a Stop signs at the following locations:


- Knightsbridge Road at Longworth Road;
- Marigold Street and Father Dalton Avenue; and
- Quarrier Road at Pelkey Road.

Due to completed residential construction, it is proposed to install Yield Signs at the following locations:

- Westbound Bradwell Chase at Humberside Common (north intersection);
- Eastbound and westbound Bradwell Chase at Meadowlands Way;
- Southbound Bradwell Court (east and west intersection) at Bradwell Chase;
- Eastbound and westbound Callingham Drive at Meadowlands Way;
- Southbound Humberside Common at Bradwell Chase (south intersection);
- Northbound Humberside Common at Callingham Drive; and
- Northbound and southbound Meadowland Way at Callingham Drive.

Staff received a request to install an all-way stop at the intersection of Knightsbridge Road at Longworth Road to address speeding concerns. It should be noted that all-way stops should not be used for traffic calming. A traffic study was conducted and volumes do not meet the all-way stop warrant. Other measures may be possible to address speeding concerns after Longworth Road has been assumed by the City.

An amendment is required to Schedule 10 (Stop Sign Locations) and Schedule 11 (Yield Signs).



7. No Parking In Posted Locations

Staff was requested to review the current parking restrictions within the vicinity of Canada Post Community Mail Boxes (CMB) due to concerns that residents have difficulty retrieving their mail when vehicles are parked in front of the CMB.

The Traffic & Parking By-law currently does not restrict parking within the vicinity of the CMB. It is recommended to implement parking restrictions within 1.0 metre from a CMB, if the CMB is facing the street and has no sidewalk access. It should be noted that 'no parking' signs will be erected at the applicable CMBs to designate the no parking zone.

An amendment is required to Section 10 (No Parking in Posted Locations) of the Traffic & Parking By-law (PS-111).



APPENDIX A BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. Of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. No Parking in Posted Locations

Section 10 No Parking In Posted Locations of the By-law PS-111 is hereby amended by **adding** the following:

I) within 1 metere of any Canada Post community mail box.


