Bill No. 137 2016

By-law No. L.-129(\_)-\_\_\_\_

A By-law to amend By-law No. L.-129-51 being "A by-law to provide for the licensing, regulating and governing of vehicles for hire, including cab, accessible cab, limousine and group transportation vehicle drivers, owners and brokers".

WHEREAS the Council of The Corporation of the City of London wishes to amend By- law L.-129-51 being "A by-law to provide for the licensing, regulating and governing of vehicles for hire, including cab, accessible cab, limousine and group transportation vehicle drivers, owners and brokers" and entitled the "Taxi and Limousine Licensing By- law";

AND WHEREAS section 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Council of The Corporation of the City of London enacts as follows:

- 1. Subsection 1.1. in Schedule "A" of the Taxi and Limousine Licensing Bylaw L.-129-51 is hereby amended by:
  - (a) amending subsection 1.1(i) by deleting the word "and" from the end of the paragraph;
  - (b) adding the following new subsection 1.1(j):
    - "(j) submit to the Licence Manager a valid GST/HST program account number; and";
  - (c) re-numbering subsection 1.1(j) as 1.1(k).
- 2. Section 3.1 in Schedule "A" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by deleting subsection 3.1(d) and replacing it with a new subsection 3.1(d) as follows:
  - "(d) Operate a Cab or Accessible Cab without a properly functioning roof light in accordance with subsection 2.1(c) of Schedule "D";"
- 3. Section 3.1 in Schedule "A" of the Taxi and Limousine Licensing By-law L.129-51 is hereby amended by:
  - (a) amending subsection 3.1(u) by deleting the word "Driver";
  - (b) amending subsection 3.1(w) by deleting the word "Driver";
  - (c) amending subsection 3.1(x) by deleting the word "Driver";
  - (d) amending subsection 3.1 (y) by deleting the word "and" from the end of the paragraph
  - (e) amending subsection 3.1(z) by deleting the period at the end of the sentence and replacing it with "; and";
  - (f) adding the following new subsection 3.1(aa):
    - "(aa) Operate a Cab or Accessible Cab without the number of the Owner Plate displayed on the right rear trunk hood and either on the exterior sides of both front doors or on the front fender in accordance with subsection 2.1 (i) of Schedule "D"."

- 4. Section 1.1 in Schedule "B" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by:
  - (a) amending subsection 1.1(i) by deleting the word "and" from the end of the paragraph:
  - (b) adding the following new subsection 1.1(j):
    - submit to the Licence Manager a valid GST/HST program account number; and";
  - (c) re-numbering subsection 1.1 (j) as 1.1(k).
- 5. Section 1.1 in Schedule "C" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by:
  - (a) amending subsection 1.1(i) by deleting the word "and" from the end of the paragraph:
  - (b) adding the following new subsection 1.1(j):
    - "(j) submit to the Licence Manager a valid GST/HST program account number; and":
  - (c) re-numbering subsection 1.1 (j) as 1.1(k).
- 6. Section 2.1 in Schedule "D" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by deleting subsection 2.1 (i) and replacing it with a new subsection 2.1(i) as follows:
  - "(i) the number of the Owner Plate issued for the Cab or Accessible Cab displayed in contrasting colours at least 8 centimetres high on the right rear trunk hood and either on the exterior sides of both front doors or on the front fender of the Cab or Accessible Cab;"
- 7. Section 4.1 in Schedule "D" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by deleting subsection 4.1(j) and replacing it with a new subsection 4.1(j) as follows:
  - "(j) display or permit the display of any advertisement on the Cab or Accessible Cab except for advertisement placed on the side panels of the doors or rear fender and/or an advertising sign placed on the roof of the Cab or Accessible Cab;"
- 8. Section 2.4 in Schedule "I" of the Taxi and Limousine Licensing By-law L.-129-51 is hereby amended by deleting the words "Senior Citizens" and replacing them with the words "senior citizens and students".
- 9. This by-law shall come into force and effect on the day it is passed.
