By-law No.

A By-law to approve the "Publicly Funded Organization Agreement" with CompuCom Canada Co. for Desktop Management Services and Products (DMSP-03); and to authorize the Mayor and the City Clerk to execute the Agreement; and to approve CompuCom Canada Co. as a Vendor of Record for Corporate Technology Assets and Services for the City of London.

WHEREAS subsection 5(3) of the *Municipal Act, 2001* provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS, after an open and competitive process completed by the Treasury Board Secretariat in September 2014, Her Majesty the Queen in right of Ontario has entered into an agreement with CompuCom Canada Co. for Desktop Management Services and Products VOR OSS-00466131 (DMSP-03);

AND WHEREAS the Province's agreement with CompuCom Canada Co. (DMSP-03) provides an opportunity for Provincially Funded Organizations (PFO) to enter into agreements with CompuCom Canada Co. for Desktop Management Services and Products under substantially the same terms as DMSP-03 subject to the PFO entering into a Publicly Funded Organization Agreement with CompuCom Canada Co. and establishing independent agreements (such as purchase orders) to purchase products from CompuCom Canada Co.;

AND WHEREAS Municipal Council of The Corporation of the City of London approves CompuCom Canada Co. as a Vendor of Record for Desktop Management Products;

AND WHEREAS the Products which may be purchased under the Publicly Funded Organization Agreement DMSP-03 are: Desktops (All in one Desktop, Business Desktop, Configurable Desktop, Configurable Workstation), Mobile (General Purpose Notebook, Business Notebook, Mobile Workstation, Touch Enabled Notebook), Monitors (Standard 22" Monitor, Large 24" Monitor, Extra Large 27" Monitor), Touchscreen Monitors (Standard 22" Touchscreen, Large 24" Touchscreen), Ultra Mobile (Tablet), Rugged Mobile (Rugged Notebook, Rugged Tablet, Performance Rugged Tablet), Thin Client (Thin Client Desktop, Thin Client Notebook), Apple OS (Apple Tablet, Apple Notebook, Apple Desktop, 27" Thunderbolt Display), and Android OS (Tablet);

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The Publicly Funded Organization Agreement for Desktop Management Services and Products (which allows the City to place orders and acquire Products from CompuCom Canada Co. under the same terms of the agreement between Her Majesty the Queen in right of Ontario and

CompuCom Canada Co. ["DMSP-03 Agreement"]), to be entered into between The Corporation of the City of London and CompuCom Canada Co., substantially in the form <u>attached</u> as Schedule A to this by-law, is approved.

- 2. CompuCom Canada Co. is approved as a Vendor of Record for Desktop Management Products.
- 3. The Mayor and the City Clerk are authorized to execute the agreement approved under section 1 above.
- 4. This by-law shall come into force and effect on the day it is passed.
