

SUBJECT:	DEFERRED MATTERS LIST


RECOMMENDATION

That, on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the following actions with respect to the Deferred Matters List dated March 29, 2016 **BE RECEIVED** for consideration by Committee and attached as Appendix A:
