Discussion tabled regarding the accessibility of the adjacent wading pool to this new playspace. Further commentary was received (by email after the meeting) outlining the condition of this pool (dated 1961) and that recent enhancements have already been completed to the pathway leading up to the pool, as well as the apron surrounding the pool. As such, the age and condition of the pool's infrastructure did not warrant additional accessibility enhancements to it's functional design going forward.
