## **NOTICE OF PUBLIC MEETING BEFORE THE PLANNING & ENVIRONMENT COMMITTEE for OFFICIAL PLAN AMENDMENT APPLICATION**

### **APPLICANT:**

City of London

### **LOCATION:**

London Psychiatric Hospital Secondary Plan - see attached map

### **PURPOSE AND EFFECT:**

The purpose and effect of the proposed amendment is to attach policies from the current Official Plan for the City of London that are referenced in the Secondary Plan. Upon adoption of the new Official Plan for the City of London (The London Plan), the current policies that are referenced in the Secondary Plan will no longer be in force and effect, therefore, these policies are proposed to be added to the Secondary Plan.

### **POSSIBLE AMENDMENT:**

Amend Section 20.4 London Psychiatric Hospital Secondary Plan, of the Official Plan to add all policies from the current Official Plan that are referenced in the Secondary Plan.

### **PUBLIC MEETING:**

By letter dated July 3, 2014, you were informed of the possible amendment described above.

You are now advised that the Planning & Environment Committee will consider this application at its meeting on **Monday, May 9, 2016 no earlier than 5:00 p.m.** Meetings are held in the Council Chambers of City Hall, located at 300 Dufferin Avenue (north-east corner of Wellington Street). Each application is allocated a time for public delegations. It should be recognized however, that the Planning & Environment Committee may find it necessary to exceed the limit. Your co-operation is appreciated in the event that you have to wait for your application to be considered.

**Please Note:** Personal information collected and recorded at the Public Participation Meeting, or through written submissions on this subject, is collected under the authority of the Municipal Act, 2001, as amended, and the Planning Act, 1990 R.S.O. 1990, c.P.13 and will be used by Members of Council and City of London staff in their consideration of this matter. The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.

A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

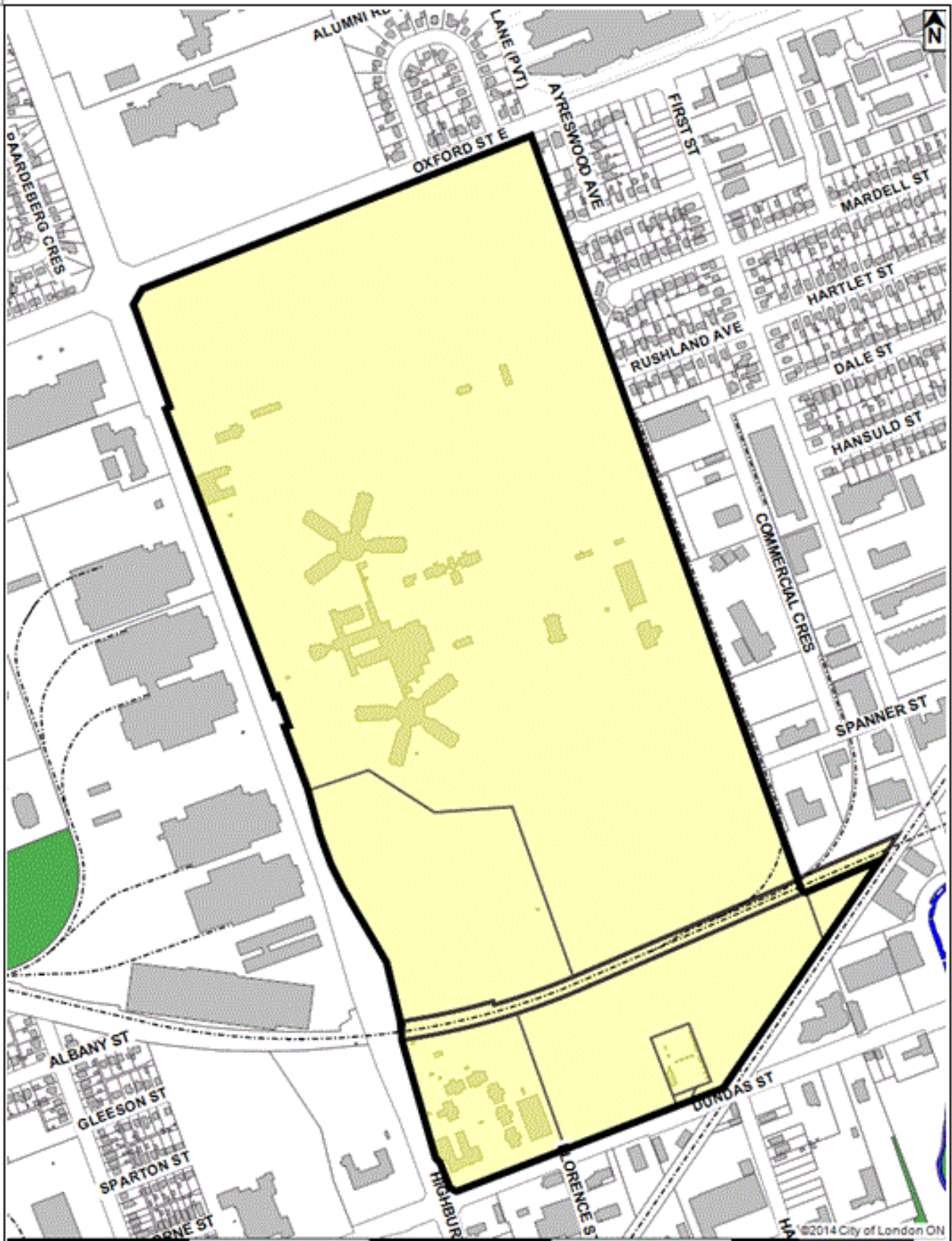
