# NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering a City-wide amendment to the City's Zoning By-law. The possible change is described below. We are advising you of this application to invite your comments.

# **PURPOSE AND EFFECT:**

The purpose and effect of the requested Zoning By-law amendment is to amend the definition of "Private Home Day Care" to increase the number of persons permitted under temporary care within a licensed home day care from five (5) to six (6), in accordance with changes to the Ontario *Child Care and Early Years Act, 2014*. Changes to the "Home Occupation" section of the Zoning By-law may also be necessary to reflect the changes to the "Private Home Day Care" definition.

## **POSSIBLE AMENDMENT:**

Possible Amendment to "Section 2 – Definitions" section of Zoning By-law Z.-1 to amend the definition of "Private Home Day Care" to reflect provisions of the Ontario *Child Care and Early Years Act, 2014* to increase the number of persons under temporary care in a licensed home day care facility from five (5) to six (6). Possible amendment to "Section 4.10 – Home Occupations" of the General Provisions section of Zoning By-law Z.-1 may also be necessary to reflect changes to the "Private Home Day Care" definition, as amended.

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.
