December 12, 2005 – Information report to Planning Committee regarding a process for planning the redevelopment of the London Psychiatric Hospital Lands.


April 21, 2009 – Meeting to table the draft London Psychiatric Hospital Lands Area Plan Terms of Reference and circulate it for comment.

January 16, 2012 – Staff report seeking direction on the appeal of the Secondary Plan to the Ontario Municipal Board by the Fairmont Lawn Bowling Club.

## **BACKGROUND**

On January 31, 2012, Council resolved, in response to the appeal to the London Psychiatric Hospital Secondary Plan by the Fairmont Lawn Bowling Club, that the Ontario Municipal Board **BE ADVISED** that the Municipal Council has reviewed its decision relating to this matter and sees no reason to alter it. At the preceding Planning & Environment Committee meeting, the Planning Division Administration was asked to explore opportunities for resolving the Lawn Bowling Club appeal. As a result, the administration contacted Infrastructure Ontario, who indicated they would be meeting with Club in order to discuss the appeal. While City staff offered to assist if needed by the two organizations, Infrastructure Ontario declined to have the City participating in those discussions.


