RE: Monthly Report for March 2016

Attached are the Building Division's monthly report for March 2016 and copies of the Summary of the Inspectors' Workload reports.

Permit Issuance

By the end of March, 834 permits had been issued with a construction value of approximately \$285 million dollars, representing 852 new dwelling units. Compared to last year, this represents a 2.2% increase in the number of permits, a 60% increase in the construction value and a 168% increase in the number of dwelling units.

To the end of March, the number of single and semi-detached dwellings issued was 163, which was a 34% increase over last year.

At the end of March, there were 573 applications in process, representing approximately \$354 million dollars in construction value and an additional 800 dwelling units, compared with 486 applications having a construction value of \$236 million dollars and an additional 542 dwelling units for the same period last year.

The rate of incoming applications for the month of March averaged out to 21.5 applications a day for a total of 453 in 21 working days. There were 79 permit applications to build 79 new single detached dwellings, 17 townhouse applications to build 20 units, of which 14 were cluster single dwelling units.

There were 338 permits issued in March totalling \$151.9 million including 713 new dwelling units.

Inspections

Although multiple inspections may be booked and completed for a project on the same day (ie. structural framing and HVAC rough-in), only one inspection is counted in this report. This provides a more accurate depiction of the inspectors' workload.

Building Inspectors received 1,140 inspection calls and conducted 1,399 building permit related inspections with an additional 4 inspections completed relating to complaints, licenses, orders and miscellaneous inspections. This is a total of 1,403 inspections or an average of 140 inspections made per inspector this month based on 10 inspectors, which averages out to 9.2 inspections per day per inspector. (Note: 210 person working days – 58 vac/sick day/training = 152) There are a total of 8,662 active building permits or an average of 787 permits per inspector. The provincially mandated requirement to inspect within 48 hours of receipt of an inspection request was achieved 99.9% of the time.

Plumbing Inspectors received 811 inspection calls and conducted a total of 935 permit related inspections, there were 0 inspections performed that related to the Backflow Prevention Program. Inspections relating to complaints, orders and miscellaneous calls totalled a further 2 inspections. During the month, a total of 937 inspections were conducted with an average of 187 per inspector, which averages out to 10.9 inspections per day per inspector. (Note: 105)




