- 8. That the following actions be taken with respect to the 3<sup>rd</sup> Report of the Accessibility Advisory Committee (ACCAC) from its meeting held on March 24, 2016:
- a) the following actions be taken with respect to the Built Environment and Facilities Sub-Committee (BEFSC) Report:
  - the following actions be taken with respect to the new Southwest Community Centre (SCC):
    - the London Transit Commission (LTC) BE ENCOURAGED to consider providing transit access to the above-noted Centre at its Southdale Road entrance, prior to its opening;
    - b) the Civic Administration BE REQUESTED to consider traffic lights and/or a pedestrian crosswalk on Southdale Road in proximity to the building, prior to its opening; and,
    - the Civic Administration BE REQUESTED to review the Facility Accessibility Design Standard (FADS), section 4.2.7 with respect to the provision of a variable-height change table within any barrier-free washroom or change room provided; it being noted that presently FADS 4.2.7 simply requires that an accessible individual washroom "shall incorporate a change table" at a height no greater than 865mm (34 inch);

- iv) it BE NOTED that the BEFSC minutes from its meeting held on February 4, 2016, were received;
- b) the following actions be taken with respect to the Mental Health Working Group (MHWG) Reports:
  - i) M. Dawthorne BE APPOINTED as the Lead for the MHWG;
  - ii) the Civic Administration BE REQUESTED to contact the Chair of ACCAC to clarify the request and/or outstanding questions with respect to the existing mental health initiative programs; it being noted that the recommendation of the ACCAC read as follows:

#### ACCAC recommendations to the Mayor's Poverty Panel

The ACCAC would like to thank the Mayor's Poverty Panel for doing a great job in producing the draft report. We would like to recommend the panel consider the following points when finalizing their report:

- A. There are no recommendation to increase ODSP or ACSD. Often when OW or minimum wage increase without comparable increases in ODSP/ACSD, persons with disabilities (PWD) and their families end up further behind.
- B. Address the expense of obtaining a police record check for employment by persons in receipt of social assistance (OW, ODSP, ACSD, CPP, etc) to allow easier access to work.
- C. Increased supports in education are significantly needed for persons with developmental disabilities, mental health disabilities, and many other forms of disabilities. It is short-sighted to develop strategies that support only one portion of the PWD population in this regard.
- D. There is significant focus on indigenous population; almost to the neglect of other disproportionately impoverished populations, including persons with disabilities. If the 'short term' thinking that goes into finalizing these recommendations fails to mention PWD, it is unlikely any long-term change will occur. London's Anti-poverty Strategy: Literature review (April 17, 2008) found "Persons with disabilities in London comprise 26.9% of the low-income population". If PWDs account for over a quarter of people experiencing low income, why are only 6 recommendations related specifically to this population. By comparison, indigenous population comprised 3.4% yet are repeatedly focus of numerous specific recommendations. We do not think the panel intended to 'favour' or 'diminish' the value of any one group, but we do STRONGLY encourage the panel to focus more heavily on PWD with its recommendations.
- E. Maintain and promote the ACCAC Funding Guide for PWD in London (currently part of the 2016 ACCAC work plan, but may not be continued in the future if not planned for)
- F. Many CNIB card holders rely heavily on the subsidized transit. Be aware the elimination of the pass in favour of a new needs based plan will adversely impact many blind and low vision Londoners. That said, we strongly support a more widespread subsidy plan for transit and participated in a city committee that reviewed options.y

In conclusion, recommendations should speak to multiple barriers. Often times persons experiencing multiple forms of marginalization (age, gender, ability, race, language, etc) are not well served by existing programs focusing on one segment of the population; or are considered 'out of mandate' for a particular organization. These leave individuals and families struggling further for resources and supports and significantly increase chances for poverty. At a minimum the city should commit to reviewing, and where necessary, removing mandate barriers that could inadvertently prevent access to services.

Thank you for considering our recommendations and we look forward to the final report.
