- 1. FDK Classroom Allocations September 2016 We are projecting approximately 380 FDK classrooms for September 2016. This year we have 370 classrooms.
- Request for Proposals for the new NW school and NE school child care centre operators is planned to be distributed by the end of June at the same time as the Family Centre Expression of Interests.
 Each of the two child care centres will be licensed for 88 child care spaces (1 room @ 10 infants, 2 rooms @ 15 toddlers each, 2 rooms @ 24 preschoolers each).
 The child care and family centre design plans are close to complete. A task group has been formed to develop the furniture and equipment requirements. Child care build and
- 3. Of the 8 Child Care Operators who offer before and after school programs, 7 have been able to accommodate all families on the waiting lists. LCC is currently working on their waiting lists and hope to accommodate as many families as possible.

- Full Day Kindergarten continues to move forward with a slight increase in numbers expected next September – again, the greatest impact on numbers seems to be in our French Immersion Programs
- Our staffing has settled and we do not anticipate any redundancies this year and it is too early to tell if we will need additional staff for September
- Westminster Family Center is moving forward currently we are in the process of determining the back bone lead agency and hopefully that will be announced soon – we are very excited moving forward with the renovations on this new center
- A new Superintendent has been announced Vince Romeo will be taking over for Sharon Wright Evans who will be retiring this year
