SUBJECT:	TECHNICAL AMENDMENT TO BY-LAW NO. L.S.P.-3389-65 MATHERS CEMETERY MEETING ON JUNE 8, 2016

RECOMMENDATION

That, on the recommendation of the Managing Director, Planning and City Planner, Municipal Council **AMEND** designating By-law No. L.S.P.-3389-65 to correct the municipal address of the Mathers Cemetery from 3557 Colonel Talbot Road to 3551 Colonel Talbot Road, pursuant to Section 30.1(1) of the *Ontario Heritage Act*.

PURPOSE AND EFFECT OF RECOMMENDED ACTION

The effect of the recommended action is to correct an error in the address identified within the designating by-law for the Mathers Cemetery.

BACKGROUND

The Mathers Cemetery is a significant cultural heritage resource. The cemetery contains the graves of three members of the Mathers family who were early pioneers in the former Westminster Township. The Mathers Cemetery was designated under Part IV of the *Ontario Heritage Act* on March 26, 2007. The municipal address identified within the designating by-law for the Mathers Cemetery is 3557 Colonel Talbot Road. The Mathers Cemetery is owned by the City of London.

A fire on February 23, 2016 destroyed the home located at 3557 Colonel Talbot Road. The home was destroyed (and since demolished). The demolition address uncovered an error with the Mathers Cemetery address.

ANALYSIS

The municipal address assigned to the Mathers Cemetery is 3551 Colonel Talbot Road. The legal description of the Mathers Cemetery described in the designating by-law matches the legal description of the Mathers Cemetery property identified in Reference Plan 33R3853. The 3557 Colonel Talbot Road address identified within the designating by-law was an error and should be corrected to 3551 Colonel Talbot Road. Section 30.1(1) of the *Ontario Heritage Act* permits the correction of technical errors to designating by-laws.

CONCLUSION

A technical amendment to the designating by-law for the Mathers Cemetery should be undertaken, pursuant to Section 30.1(1) of the *Ontario Heritage Act*, to correct the address identified within the designating by-law.


