RE: Monthly Report for April 2016

Attached are the Building Division's monthly report for April 2016 and copies of the Summary of the Inspectors' Workload reports.

Permit Issuance

By the end of April, 1,310 permits had been issued with a construction value of approximately \$443 million dollars, representing 1,135 new dwelling units. Compared to last year, this represents a 10% increase in the number of permits, a 81% increase in the construction value and a 169% increase in the number of dwelling units.

To the end of April, the number of single and semi-detached dwellings issued was 243, which was a 22% increase over last year.

At the end of April, there were 464 applications in process, representing approximately \$318 million dollars in construction value and an additional 592 dwelling units, compared with 475 applications having a construction value of \$222 million dollars and an additional 565 dwelling units for the same period last year.

The rate of incoming applications for the month of April averaged out to 22 applications a day for a total of 464 in 21 working days. There were 85 permit applications to build 85 new single detached dwellings, 17 townhouse applications to build 48 units, of which 10 were cluster single dwelling units.

There were 475 permits issued in April totalling \$157.6 million including 286 new dwelling units.

Inspections

Although multiple inspections may be booked and completed for a project on the same day (ie. structural framing and HVAC rough-in), only one inspection is counted in this report. This provides a more accurate depiction of the inspectors' workload.

Building Inspectors received 1,350 inspection calls and conducted 1,489 building permit related inspections with an additional 11 inspections completed relating to complaints, licenses, orders and miscellaneous inspections. This is a total of 1,500 inspections or an average of 150 inspections made per inspector this month based on 10 inspectors, which averages out to 9.3 inspections per day per inspector. (Note: 210 person working days – 49 vac/sick day/training = 161) There are a total of 8,729 active building permits or an average of 873 permits per inspector. The provincially mandated requirement to inspect within 48 hours of receipt of an inspection request was achieved 99.3% of the time.

Plumbing Inspectors received 837 inspection calls and conducted a total of 1,007 permit related inspections, there were no inspections performed that related to the Backflow Prevention Program. Inspections relating to complaints, orders and miscellaneous calls totalled a further 6 inspections. During the month, a total of 1,013 inspections were conducted with an average of 203 per inspector, which averages out to 10.1 inspections per day per

inspector. (Note:105 person working days -5 vac/sick day/training = 100). Active building permits involving plumbing totalled 2,362 or 472 on average per inspector. The provincially mandated requirement to inspect within 48 hours of receipt of an inspection request was achieved 99.9% of the time.




