NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law for the lands shown on the attached map. The requested change is described below. We are advising you of this application to invite your comments.

APPLICANT:

2293683 Ontario Inc.

LOCATION:

2397 Oxford Street West - see attached map

PURPOSE AND EFFECT:

The purpose and effect of this zoning change is to permit the establishment of an expanded home occupation.

POSSIBLE AMENDMENT:

Change Zoning By-law Z.-1 from Residential R1 (R1-14)Zone which permits a single detached dwelling to a Residential R1 Special Provision (R1-14()) Zone which permits the addition of an expanded home occupation.

PLANNING POLICIES:

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as "Rural Settlement" in the Official Plan, which permits a range of residential, and small-scale commercial uses.

PUBLIC MEETING:

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.
