Door to Door Sales Persons

Proposed Regulations

- Business to maintain a list of employees
- Employees to submit police record check



THE CITY OF OPPORTUNITY 



Purpose of the Report

- New categories of businesses to be licensed for a variety of different municipal purposes including health and safety, nuisance control and consumer protection
- Existing categories of businesses licensed which require updated regulations

THE CITY OF OPPORTUNITY 



Payday Loan Lenders

Proposed Regulations

- Post interest rate information
- Maintain a referral list of debt counselling agencies available to clients



THE CITY OF OPPORTUNITY 



Group Homes

Proposed Regulations

- Property Standards, Fire Prevention & Health Unit
- Police records check and insurance from the Operator
- Submission of protocol for :
 - nutritional care
 - medical care (including the distribution of medication)
 - record keeping
 - infection control
 - supportive living programming (including schedule of on-site supervision)



Donation Bin Operators

Proposed Regulations

- Permission of property owner
- Standards around refuse control and posted information
- Metal bins only



Pet Shops

Proposed Regulations

- Limit the source of companion animals for retail sale to registered rescues, humane societies and animal shelters
- Licence Manager to maintain a list of permitted animals for sale



Personal Service Establishments

Proposed Regulations

- Amalgamation of a variety of Personal Service Establishment categories
- Common health-related regulations regarding cleanliness
- Compliance with any age-related provincial regulations





Adult Entertainers & Massage Parlour Attendants

Proposed Regulations

- Police record check for adult entertainer or massage parlour attendant

Contractors

Proposed Regulations

- Includes renovation work, HVAC, home improvement, driveway contractors, and pool installers
- Written quotations and insurance
- Compliance with municipal and provincial building regulations

Tobacco Vendors

Proposed Regulations

- Compliance with provincial legislation including age related regulations

Fireworks Sales

Proposed Regulations

- Compliance with all federal regulations respecting the sale of consumer fireworks
- Compliance with the City of London Fireworks By-law

Tow Truck Operators

Proposed Regulations

- Compliance with Bill 15 (posting prices, hours of work, collusion with auto repair shops)
