A by-law to amend By-law No. A-42 entitled "A by-law to provide for Various Fees and Charges".

WHEREAS subsection 5(3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS section 10(1) of the *Municipal Act, 2001* provides that a municipality may provide any service or thing that the municipality considers necessary or desirable for the public;

AND WHEREAS section 10(2) of the *Municipal Act*, 2001 provides that a municipality may pass by-laws respecting: in paragraph 7, Services and things that the municipality is authorized to provide under subsection (1);

AND WHEREAS section 391(1) of the *Municipal Act, 2001* provides that a municipality may impose fees or charges on persons:

- (a) for services and activities provided or done by or on behalf of it;
- (b) for costs payable by it for services and activities provided or done by or on behalf of any other municipality or any local board; and
- (c) for the use of its property including property under its control;

AND WHEREAS it is necessary to amend Council Policy A-42 entitled "A by-law to provide for Various Fees and Charges" to identify certain exemptions to the fee related to Display Fireworks Inspection/Permit, to make a housekeeping change to the fee related to Open Air Burn Permits, to include a new convenience fee related to parking services and to adjust certain parking fees.

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Schedule 1 to By-law No. A-42 is amended by deleting the page headed "Service Grouping: Fire Services" that contains the service area of "<u>Fire Prevention & Education</u>" and by replacing it with a new page <u>attached</u> hereto as Schedule "A".
- 2. Schedule 1 to By-law No. A-42 is further amended by deleting the pages headed "Service Grouping: Parking" and by replacing them with new pages <u>attached</u> hereto as Schedule "B".
- 3. This by-law shall come into force and effect on the day it is passed.
