## PREVIOUS REPORTS PERTINENT TO THIS MATTER

#### **BACKGROUND**

On June 13, 2016, the Planning and Environment Committee considered the adoption of The London Plan, the Official Plan for the City of London at a public participation meeting. At that meeting a representative of the Chippewas of the Thames First Nation provided a letter to the Committee noting that they did not yet have formal comments regarding the London Plan, but that comments would soon be provided.

The Council noted this in their consideration of the Plan at the meeting of June 23, 2016, and resolved that:

d) upon receipt of the comments from the Chippewas of the Thames First Nation, the Civic Administration BE DIRECTED to forward the comments to the Municipal Council and to the Minister of Municipal Affairs Housing; and,

On July 21, 2016, the attached correspondence from the Lands and Environment Department of the Chippewas of the Thames First Nation were received.

### **NEXT STEPS**

In addition to forwarding these comments to the Minister of Municipal Affairs for consideration in their approval of The London Plan, staff will review the comments for possible amendments to The London Plan. Depending on the timing of the Minister's approval of The London Plan, possible amendments in response to these comments will be brought forward at a future public participation meeting as part of a housekeeping amendment associated with the approval of the Plan.
