




Schedule E – Set Fines

The following provides a schedule of set fines, further to Section 16 of the City of London Tree Protection By-law C.P (to be filled in by Clerks). A person who is convicted of an offence under this By-law is liable for the following set fines for each day or part of a day that the offence continues.

A by-law to designate Inspectors and Officers fo the purpose of enforcing the Tree Protection By law.
WHEREAS the Municipal Council of The Corporation of the City of London passed By law C.P, as amended, "Tree Protection By-law", to prohibit and regulate the injuring and destruction of trees in defined areas in the City of London;
NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:
