SUBJECT:	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION

That on the recommendation of the Managing Director, Environmental & Engineering Services and City Engineer, the <u>attached</u> proposed by-laws (Appendix A) **BE**INTRODUCED at the Municipal Council meeting to be held on August 30, 2016 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

2015-19 STRATEGIC PLAN

The following report supports the Strategic Plan through the strategic focus area of **Strengthening Our Community** by improving safety, traffic operations and residential parking needs in London's neighbourhoods.

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix A) to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Stopping

- a) Staff received a request to review the current No Stopping restrictions on the inside of the curve on Stoneybrook Crescent opposite the Stoneybrook Public School. Concerns were raised that the No Stopping zone did not extend far enough and that vehicles parked on both sides of the street made it difficult for most users to travel safely around the curve between the parked vehicles.
 - It is recommended that the existing No Stopping zone be extended 15 meters north.
- b) Staff received a request to review the existing parking conditions on Palmer Street. Concerns were raised that when vehicles were stopped to load and unload goods and/or people, or parked on both sides of the road at Wharncliffe Road N make it difficult for drivers to negotiate the intersection.
 - It is recommended to restrict stopping on the north and south side of Palmer Street within 20 meters of Wharncliffe Road N,

An amendment is required to Schedule 1 (No Stopping) for the above.

2. No Parking

- a) Staff were requested to review the current parking restrictions on Adswood Place, McMaster Court and McNeil Place. Concerns were raised that vehicles are parking on both sides of the road making it difficult for drivers to travel safely between the parked vehicles. The road widths vary from 6.0 to 6.7 meters which typically only allows parking on one side.
 - It is recommended that parking be restricted on the west side of Adswood Place, east side of McMaster Court and the north side of McNeil Place.
- b) As per the subdivision development agreements, it is recommended to implement No Parking Anytime zones on Morgan Avenue and Singleton Avenue opposite parking bays and at curb extension.
- c) No parking is recommended on both sides of Springmeadow Road from Southdale Road W to 93 meters southerly to accommodate the safe movement of traffic around the centre median.
- d) Due to safety concerns, it is recommended that a 'No Parking Anytime' zone be implemented on the inside of the curve on Valetta Street between Woodborough Street and Plantation Road.

An amendment is required to Schedule 2 (No Parking) for the above changes.

3. Parking Surveys

At the request of local residents, mail-back parking surveys were sent to the property owners of:

- Algoma Place, where the majority of respondents supported the proposed change to implement a 'No Parking 3:00 a.m. to 5:00 a.m.' zone on both sides of Algoma Place; and
- Albion Street, where the majority of respondents supported the proposed change to implement a '2 Hour Limited Parking 8:00 a.m. to 6:00 p.m. Monday to Friday' zone on the west side of Albion Street.

An amendment is required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking) for the above changes.

4. Loading Zones

While reviewing Schedule 5 (Loading Zones), it was discovered that the Loading Zone on Tweedsmuir Avenue from Court Lane (west Intersection) to Court Lane (east intersection) conflicts with the existing No Stopping zone and should be removed from Schedule 5.

An amendment is required to Schedule 5 (Loading Zone) for the above change.

5. Load Restrictions

In July 2015 Municipal Council approved revised designated haul routes to the W12A Landfill which includes the use of Wonderland Road S and Manning Drive. Improvements have been completed to Manning Drive; therefore, it is appropriate to remove the spring load restriction on Manning Drive from Wonderland Road S to the entrance to W12A Landfill.

Improvements were also made to the pavement on Bradley Avenue from Jackson Road to the Veterans Memorial Parkway. The spring load restriction is no longer needed on Bradley Avenue.

An amendment is required to Schedule 15 (Reduced Load Limit) for the above changes.

6. School Zone Speed Limit

It recommended that the speed limit be reduced to 40 km/h at the following locations as per the School Zone Speed Limit Policy recently approved by Council:

Amendments are required to Schedule 17.1 (Reduced Speed Limit) for the above changes.

APPENDIX A BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. Of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:
