

Thames Valley Parkway North Branch Connection Richmond Street to Adelaide Street Class Environmental Assessment Study




Notice of Completion

The City of London completed a Municipal Class Environmental Assessment (EA) study to identify the preferred alternative to complete an existing gap in the Thames Valley Parkway (TVP) between Richmond Street and Adelaide Street. The preferred alignment is shown on the map below. The preferred alignment includes two new pedestrian bridges; one to Ross Park and one to the North London Athletic Fields, with the pathway connecting the bridges north of the river.

The study was completed in accordance with the planning and design process for a Schedule 'B' project under the Municipal Class EA (2000, as amended) under the Ontario *Environmental Assessment Act*.

The preferred alternative was presented to the public at the November 17, 2015 Public Information Centre (PIC). Following the PIC, the preferred alternative was reviewed and refined based on comments received. An Environmental Impact Study (EIS) was completed for the preferred alignment.



An Environmental Screening Report (ESR) was prepared to document the study decision-making process. The EIS is included as an Appendix to the ESR. The ESR will be available for public and agency review, from **August 11, 2016 to September 12, 2016**.
