The Ontario Ministry of Transportation (MTO) is undertaking the Detailed Design and Class Environmental Assessment (EA) study for the reconstruction of Highway 401 from Elgin Road 8 (Currie Road) to Elgin Road 20 (Union Road) in Elgin County (G.W.P. 3132-12-00), and from Elgin Road 20 (Union Road) to Highway 4 (Colonel Talbot Road), in the Counties of Elgin and Middlesex, and the City of London (G.W.P. 3093-12-00). The enclosed Ontario Government Notice provides a key plan and additional details for your reference.

Information regarding the proposed improvements, anticipated start date and duration of construction, as well as traffic management during construction will be posted to the project website (www.hwy401reconstruction.ca) as the project proceeds.

NOTICE OF STUDY COMMENCEMENT

Detailed Design and Class Environmental Assessment Study Highway 401 Reconstruction, Counties of Elgin and Middlesex, and the City of London Project Reference: G.W.P. 3132-12-00 & 3093-12-00

THE PROJECT

The Ontario Ministry of Transportation (MTO) is undertaking the Detailed Design and Class Environmental Assessment (EA) study for the reconstruction of Highway 401 from Elgin Road 8 (Currie Road) to Elgin Road 20 (Union Road) in Elgin County (G.W.P. 3132-12-00), and from Elgin Road 20 (Union Road) to Highway 4 (Colonel Talbot Road), in the Counties of Elgin and Middlesex, and the City of London (G.W.P. 3093-12-00). The limits of reconstruction are shown on the key plan.

Subject to the outcome of the study, the Ministry is proposing the following improvements:

- Approximately 28 km of full depth pavement reconstruction requiring four years of construction
- Drainage improvements
- Replacement/rehabilitation of bridges and culverts
- Environmental protection and mitigation, where required

A construction staging and traffic management plan will be developed and will address associated ramp closures and temporary traffic impacts. One lane of traffic will be maintained in each direction on Highway 401 throughout construction. Information regarding construction staging and traffic management will be posted on the project website (www.hwy401reconstruction.ca).

THE PROCESS

This project is following the approved planning process for Group 'C' projects in accordance with the *Class Environmental Assessment (EA) for Provincial Transportation Facilities (2000)*. An Environmental Screening Document (ESD) will be prepared for each contract for an internal record to describe the proposed works and identify environmental mitigation measures. No public review period will be provided for these documents. Group 'C' projects are considered approved under the *Ontario Environmental Assessment Act*, subject to compliance with the Class EA and the application of mitigation measures where necessary.



LE PROJET

Le **ministère des Transports** de l'Ontario entreprend l'étude de conception détaillée et d'évaluation environnementale pour la reconstruction de l'autoroute 401, de la route Elgin 8 (route Currie) à la route Elgin 20 (route Union dans le comté de Elgin (G.W.P. 3132-12-00), ainsi que de la route Elgin 20 (route Union) à l'autoroute 4 (route Colonel Talbot), dans les comtés de Elgin et de Middlesex et dans la ville de London (G.W.P. 3093-12-00). Les limites de la reconstruction sont indiquées sur le plan repère.

En fonction des résultats de l'étude, le ministère propose les améliorations suivantes :

- Reconstruction en profondeur de la chaussée sur environ 28 km nécessitant quatre années de construction;
- Améliorations du drainage;
- Remplacement et réhabilitation des ponts et ponceaux;
- Protection de l'environnement et atténuation des risques environnementaux, au besoin.

Un plan relatif aux étapes de la construction et à la gestion de la circulation sera élaboré et abordera les fermetures des bretelles associées et les effets temporaires sur la circulation. Une voie de circulation sera maintenue dans chaque direction sur l'autoroute 401 tout au long de la construction. L'information concernant les étapes de construction et la gestion de la circulation sera publiée sur le site Web du projet (www.hwy401reconstruction.ca).

LE PROCESSUS

Ce projet respecte le processus de planification approuvé pour les projets de groupe « C » conformément à l'*Évaluation environnementale de portée générale pour les routes provinciales (2000)*. Un document d'examen environnemental préalable (EEP) sera préparé pour chaque contrat pour un dossier interne afin de décrire les travaux proposés et cerner les mesures d'atténuation des risques sur l'environnement. Aucune période d'examen public n'est prévue pour ces documents. Les projets de groupe « C » sont considérés comme étant approuvés en vertu de la *Loi sur les évaluations environnementales*, en plus de devoir être conformes à l'évaluation environnementale de portée générale et aux mesures d'atténuation des risques sur l'environnement, le cas échéant.

COMMENTAIRES


