- (a) The following Consulting Engineering firms **BE APPOINTED** Consulting Engineers for the pre-design and design of the said projects, at the upset amounts identified below, including contingency and exclusive of HST, in accordance with the estimate on file, based upon the Fee Guideline for Professional Engineering Services, recommended by the Ontario Society of Professional Engineers; and in accordance with Section 15.2 d of the City of London's Procurement of Goods and Services Policy; it being noted that these consultants may obtain approval to proceed with subsequent phases of engineering for their projects subject to satisfying all financial, reporting and other conditions contained within this Policy:
 - (i) Contract 18: Archibald, Gray & McKay Engineering Limited, in the amount of \$228,302.00.
 - (ii) Contract 19: AECOM Canada Ltd, in the amount of \$253,602.00.
 - (iii) Contract 20: Ricor Engineering, in the amount of \$188,680.00.
- (b) the financing for design of the projects identified in (a), above, **BE APPROVED** in accordance with the "Sources of Financing Report" attached hereto as Appendix "A;
- (c) the Civic Administration **BE AUTHORIZED** to undertake all the administrative acts that are necessary in connection with this work; and,
- (d) the approvals given herein **BE CONDITIONAL** upon the Corporation entering into a formal contract with each Consultant for the respective project;
- (e) the Mayor and City Clerk **BE AUTHORIZED** to execute any contract or other documents, if required, to give effect to these recommendations.

2015-19 STRATEGIC PLAN

The following report supports the Strategic Plan through a focus on Building a Sustainable City by addressing and managing our infrastructure gap, managing and improving services, and funding Climate Change adaptation.

BACKGROUND

Purpose

The Phase 1 CWWF criteria stipulates that projects under the fund must be completed by March, 2018. This report is to award consulting engineering assignments for anticipated projects.

Background

A number of CWWF projects require immediate initiation in the form of engineering assignments to meet the funding program's March 2018 Phase 1 completion deadline. Completing them on time is critical to maximizing the 75% cost recovery available in the program.

The projects recommended for design in this report fit the criteria of the CWWF, particularly so because of their sewer separation components. They represent an expansion to an existing program of infrastructure improvement.

Discussion

Following the procurement practices established through our annual Infrastructure Renewal Program, this report recommends the appointment of Engineering Consultants for three engineering design assignments as identified in Appendix 'B'. Engineering services during construction and construction contract approval recommendations will follow design and tender of each project.

Should the Phase 1 CWWF application be successful the Environmental & Engineering Services Area (EES) plans to deliver these additional projects with existing internal resources. EES is, however, reviewing resource commitments when considering potential Phase 2 project workloads, including those needed in Water and Wastewater & Treatment to support transportation projects that may arise from the Phase 1 (and subsequent phases) Public Transit Infrastructure Funding opportunities.

The authorization to award these consulting assignments, at this time, provides the best opportunity for these projects to be completed within the timeline specified in the criteria of the Clean Water and Wastewater Fund. This will allow the City to fully utilize this important opportunity to improve City infrastructure with funding from the provincial and federal governments.

Acceleration strategies for other anticipated CWWF projects are under development and will be the subject of future reports.

Each year the City completes approximately ten reconstruction projects under the Infrastructure Renewal Program. These projects typically include watermain and sewer replacement/repairs, as well as restoration of areas disturbed by the construction activity. The projects support the objectives identified in the Strategic Plan under Building a Sustainable City — Robust Infrastructure, by implementing Water and Wastewater Renewal Plans that address the infrastructure deficit. Typically, consulting engineers are assigned for the Infrastructure Renewal Program in June of the year before construction.

The Clean Water and Wastewater Fund gives the City an important opportunity to expand the number of projects to be done in 2017 with provincial and federal government funding. To better fit the criteria of the fund, projects have been chosen that have a sewer separation component.
