SUBJECT	TENDER 12-45 FORKS OF THE THAMES LOOKOUT

RECOMMENDATION

That on the recommendation of the Director of Planning, the following actions **BE TAKEN** with respect to Tender 12-45:

- 1. That the bid submitted by Frank Van Bussel & Sons Ltd., P.O. Box 340, 3 Ilderbrook Circle, Ilderton, Ontario N0M 2A0 at their tendered price of \$462,731.06 including contingency, excluding HST **BE ACCEPTED**, it being noted that Frank Van Bussel is the low bid and meets the terms, conditions and specifications.
- 2. That additional annual operating costs of \$10,000, **BE APPROVED** as a first priority commitment from available assessment growth in 2013, subject to final budget approval.
- 3. That Civic Administration **BE AUTHORIZED** to undertake all of the administrative acts that are necessary in connection with this contract;
- 4. That approval hereby given **BE CONDITIONAL** upon the Corporation entering into formal contract or issuing purchase orders or contract record relating to these matters of this approval.

BACKGROUND

Purchasing Process

Five bids were received as a result of this tender call March 7, 2012 as summarized in Appendix "B" attached. Frank Van Bussel and Sons Ltd. is the low bid and meets' the City's terms, conditions and specifications in all areas.

Background

Awarding Tender 12-45 to Frank Van Bussel and Sons Ltd. will allow the City to complete the final phase of construction associated with the Walter Blackburn Memorial Fountain. This project will be constructed in Riverside Park, as contemplated in the Forks of the Thames Revitalization Master Plan. It will include a formal urban civic space, coloured concrete walkways, seating, a shade structure, pathway lighting and coloured LED lights to enhance the Fountain. The project also includes improved pedestrian and cycling connections between Dundas Street and the Dundas/Queens Street Underpass which was constructed in 2010.

Implementation of this project will achieve objectives outlined in the recently approved Thames Valley Corridor Study and the City of London Bicycle Master Plan while also meeting goals associated with the developing Down Town Master Plan.

City staff has taken steps that meet expectations outlined in the recently approved Public Engagement Policy. This specific phase of construction would represent a project that requires 'Consultation' under this new policy. An extensive public engagement process was undertaken during the conceptual design stage of the Forks Master Plan. In addition, sign boards were posted in Riverside Park and a web page maintained throughout 2010/2011 that described this final phase of construction. Staff has received very positive feedback on both the recent improvements made in Riverside Park and on the anticipated pedestrian space overlooking the Walter Blackburn Memorial Fountain.

Implementation of this project will start in May with an expected completion date in early fall, 2012 and will provide improved access to the Thames River park system.
