BACKGROUND

The <u>attached</u> Resolution of the Shareholder formalizes the appointment of KPMG LLP as auditors of London Hydro Inc.

Pursuant to the *Business Corporations Act*, R.S.O. 1990, c. B.16, at each annual meeting, the shareholder is required to appoint on auditor to hold office until the close of the next annual meeting and if an appointment is not so made, the auditor in office continues until a successor is appointed.

At the 2015 annual meeting of the shareholder for London Hydro Inc. an auditor was not appointed as the City was undergoing an RFP process for external audit services. KPMG LLP was appointed as the City's external auditor on October 12, 2016. Such appointment includes the provision of audit services to London Hydro Inc.
