NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law for the lands shown on the attached map. The requested change is described below. We are advising you of this application to invite your comments.

APPLICANT:

Peter Jordan

LOCATION:

3668 Homewood Lane - see attached map

PURPOSE AND EFFECT:

The purpose and effect of the requested Zoning By-law amendment is to allow for a building expansion to the existing farm dwelling and a zone boundary adjustment to correspond to the existing lawn, driveway, paddock and barn areas and natural heritage areas.

POSSIBLE AMENDMENT:

Change Zoning By-law Z.-1 from an Agricultural (AG2) Zone which permits farm dwellings and an Environmental Review (ER) Zone which permits such uses as passive recreational uses and agricultural uses to an Agricultural Special Provision (AG2(_)) Zone to permit a farm dwelling with a minimum building setback of 2.9 metres and an Open Space (OS5) Zone which permits: conservation lands; conservation works; passive recreational uses and managed woodlots.

A reduced building setback on the site was the subject of a previously approved minor variance application (File: A142/16).

PLANNING POLICIES:

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as "Agriculture" (which permits a range of agricultural related uses, including farm dwellings), "Environmental Review" (which permits agriculture, woodlot management, horticulture, and conservation uses) and "Open Space" (which permits agriculture, woodlot management, horticulture, and conservation uses).

The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. Questions about this collection should be referred to Cathy Saunders, City Clerk, 519-661-2500 extension 4937. A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

PUBLIC MEETING:

The appropriateness of the requested Zoning By-law amendment will be considered at a future meeting of the Planning & Environment Committee. You will receive another notice inviting you to attend this meeting.

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.

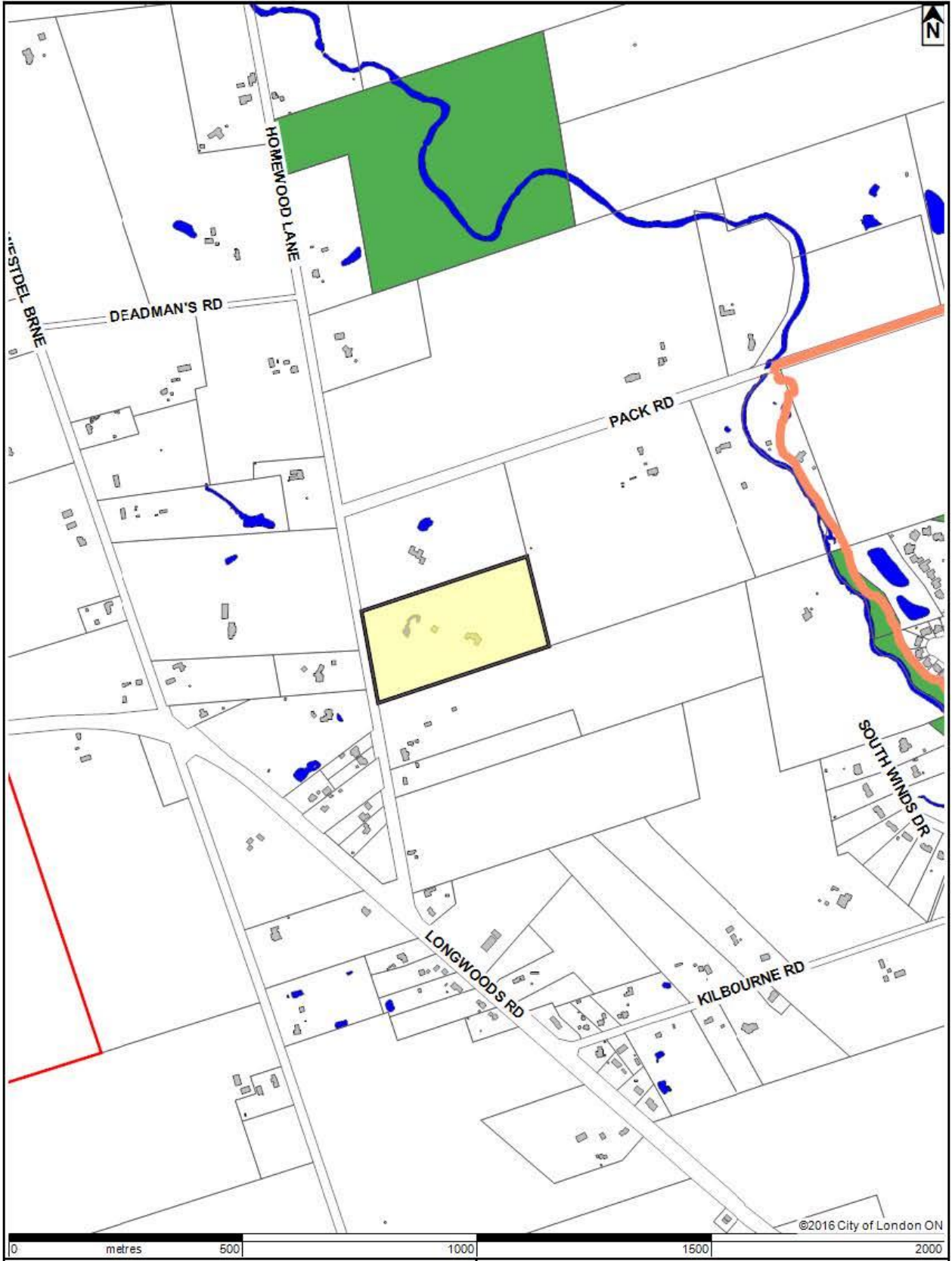
