SUBJECT	AMENDMENTS TO THE TRAFFIC AND PARKING BY-LAW

RECOMMENDATION


That on the recommendation of the Acting Executive Director, Planning, Environmental & Engineering Services & City Engineer, the <u>attached</u> proposed by-law (Appendix "A") **BE INTRODUCED** at the Municipal Council meeting to be held on April 10, 2012 for the purpose of amending the Traffic and Parking By-law (P.S. 111).

BACKGROUND

The Traffic and Parking By-law (P.S.111) requires amendments (Appendix "A") to address traffic safety, operations and parking concerns. The following amendments are proposed:

1. No Stopping, No Parking, Limited Parking, Bus Stops and School Bus Loading Zones

- a) London Transit Services expressed a concern that vehicles are parked within the bus stop on the west side of Base Line Road West just south of Southcrest Drive. It is necessary to establish No Parking within the Bus stop zone on Base Line Road West. An amendment is required to Schedule 3(Bus stops).
- b) A new bicycle lane will be installed on Cheapside Street between Victoria Avenue and Fanshawe College Boulevard. It is necessary to prohibit parking on the south side of Cheapside Street just east of Highbury Avenue to accommodate new bike lanes. An amendment is required to Schedule 2 (No Parking) and Schedule 6 (Limited Parking).
- c) London District Catholic School Board requested a revision of No Stopping and No Parking zone in front of the St. Martin Separate School on Duchess Avenue. It is proposed revise No Stopping zone time limit from 8 am 6 pm to 8 am 4 pm and replace portion of No Stopping zone in front of the school with No Parking zone Monday to Friday, September to June. Stopping momentarily to drop-off or pick-up students will still be allowed. Amendments are required to Schedule 1 (No Stopping), Schedule 2 (No Parking) and Schedule 9 (School Bus Loading Zones).
- d) Due to sightline issues associated with vehicles parking on Green Gables Road north of McNeil Road it is proposed to dedicate "No Parking Anytime" zone on the west side of Green Gables Road from McNeil Road and 45 m northerly. An amendment is required to Schedule 2 (No Parking).
- e) A new curb face concrete sidewalk was recently constructed on the west side of Manchester Road from Royal York Road to 90m north of Hunt Club Drive. The road width has been reduced and it is proposed to prohibit parking on the east side of Manchester Road to allow for safe traffic movement. An amendment is required to Schedule 2 (No Parking).
- f) At the request of residents, a mail-back survey was conducted on Oakcrossing Road to determine if the homeowners supported "No Parking Anytime" zone on the south side of Oakcrossing Road from Oakcrossing Gate to property limits of Mun # 1235 and Mun # 1267. The results of the mail-back survey indicated that the majority of respondents supported the parking regulation change. An amendment is required to Schedule 2 (No Parking).



- g) There are ongoing safety concerns with vehicles parked on the shoulder of Pond Mills Road. Parked vehicles create sightline issues for vehicles entering the road from adjacent driveways. Originally the on street parking was created to facilitate the needs of a nearby place of worship and this additional parking is no longer required. It is proposed to prohibit parking on the west side of Pond Mills Road between Hwy 401 and Wilton Grove Road. An amendment is required to Schedule 2 (No Parking).
- h) Northdale Public School on Tennant Avenue was recently demolished and it is necessary to remove School Bus Loading zones and No Stopping zones. Amendments are required to Schedule 1 (No Stopping) and Schedule 16 (School Bus Loading Zones).
- Parking bays with curb extensions were constructed in new subdivisions as a part of requirements to address traffic calming. On-street parking should be restricted at the end and on the opposite side of parking bays to ensure that there are no vehicles parked in the narrowed street area at the following locations:

Amendments are required to Schedule 2 (No Parking).

2. Yield Signs

- a) New yield sign is required to address right-of-way control in a new subdivision at the following intersections:
 - Castlehill Close at Sawgrass Link
 - Gallaway Road at Royal Oaks Bend
 - Pebblecreek Walk at Torrey Pine Way
 - Poppy Court at Baird Street.



- Royal Oaks Bend at Pebblecreek Walk
- Sawgrass Link at Pebblecreek Walk

Amendments are required to Schedule 11(Entering Highway - Yield Signs).

3. Stop Signs

- a) It is necessary to relocate existing stop sign at the north intersection of Langley Street with Tecumseh Avenue from Langley Street southbound direction to Tecumseh Avenue eastbound direction where Tecumseh Avenue dead ends at Langley Avenue.
- b) New stop signs are required to address right-of-way control in a new subdivision at the following intersections:
 - Royal Oaks Bend at Villagewalk Boulevard
 - Torrey Pines Way at Villagewalk Boulevard



Amendments are required to Schedule 10 (Entering Highway - Stop Signs).

4. One Way Streets

a) It is necessary to designate Poppy Court as one way street to allow for proper traffic movement. An amendment is required to Schedule 12 (One Way Streets).

5. Through Highways

- a) Blackwater Road was originally designated as through highway from Grenfell Drive to north end of the street. With expansion of the subdivision, Blackwater Road was extended to Sunningdale Road East. It is necessary to extend the limits of Blackwater Road as a through highway from Grenfell Drive to Sunningdale Road East.
- b) SSunningdale Road was originally designated as through highway from Richmond Street to Highbury Avenue. It is necessary to change the limits of Sunningdale Road as a through highway from Wonderland Road North to Clarke Road and to revise street direction as it currently exists.

Amendments are required to Schedule 13 (Through Highways).

6. Revised Speed Limits

a) Wonderland Road South is currently posted at 70 km/hr from the Exeter Road to Southdale Road West. It is recommended to reduce the speed limit to 60 km/hr from Southdale Road West to 100m south of Bradley Avenue (extension) due to recent commercial development in the area. An amendment to Schedule 17 (Higher Speed Limits) is required.

7. Typographical Errors

a) A review of the by-law found typographical error in Section 2 (No Parking). Brunswick Avenue must be replaced with Brunswick Crescent. An amendment is Required to Schedule 2 (No Parking)



APPENDIX "A" BY-LAW TO AMEND THE TRAFFIC & PARKING BY-LAW (P.S. 111)

Bill No.

By-law No. PS-111

A by-law to amend By-law PS-111 entitled, "A by-law to regulate traffic and the parking of motor vehicles in the City of London."

WHEREAS subsection 10(2) paragraph 7. of the *Municipal Act, 2001*, S.O. 2001, c.25, as amended, provides that a municipality may pass by-laws to provide any service or thing that the municipality considers necessary or desirable to the public;

AND WHEREAS subsection 5(3) of the *Municipal Act*, 2001, as amended, provides that a municipal power shall be exercised by by-law;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. <u>No Stopping</u>






