BRADLEY AVENUE EXTENSION – ROAD CONSTRUCTION Wonderland Road South to Wharncliffe Road South

Dear Property Owner/Resident:

The City of London is completing the design for Bradley Avenue Road Extension project. In 2017, pending Council approval, the City plans to construct a new extension of Bradley Avenue from Wonderland Road South to Wharncliffe Road South. This letter provides you with information about the project and a public meeting.

Project Details

Location: Bradley Avenue, new road extension between Wonderland Road South and Wharncliffe Road South

Schedule: Tentative start – Spring 2017
Completion – Winter 2017

Scope: This project will include new road construction including a multi-use pathway, sidewalk, concrete curb and gutter, street lighting and the installation of new storm sewers and a new culvert crossing for the Pincombe Drain.

A road widening of Wharncliffe Road South is also proposed for the introduction of turn lanes at Bradley Avenue, including street lighting and new sidewalk


