BPPCI Mission

- The Block Parent® Program of Canada Inc. (BPPCI) is a registered charity and Canada's largest volunteer-run child safety organization. Volunteers from coast to coast help to make communities safer for everyone.
- The distinctive red and white Block Parent® window sign in the window of a home, tells children, seniors and others that help is at hand if they are lost, frightened, or in distress.
- In addition to their safety network, Block Parents offer community education programs to increase the personal safety of children, teens and seniors.
- Working together with educators and police, Block Parents help make your community safer.



History

- Program began in London in response to a rash of brutal crimes against children by the London Jewish Women's Community.
- The first Block Parent® Program began in London, Ontario in 1968. The Program rapidly expanded across Canada over the next five years. In 1983 a national committee was formed and the Block Parent® Program of Canada became incorporated in 1986.



London Block Parent Program

- At its height approximately 7,000 Block Parent homes in London
- Every school had a Block Parent coordinator who performed update administration for school area Block Parents
- Core funded by the City of London Community Services Division
- Society changes, coordinator numbers drop, therefore paid resources required for administration of BP database.



What happened?

- Federal legislation and Freedom of Information Act, changes to police check policies and procedures
- Administration processes were amended, volunteer coordinators retrained, BP office assumes additional responsibilities for schools with no coordinators or non performing coordinators.
- Governmental / Police budgets tight which affected community policing involvement resulting in cut backs of police liaison time.
- · Privacy legislation affected administration of program drastically
- RCMP Risk Assessment BPPCI low risk to BPPCI, medium to RCMP and Local/Provincial Police, recommendations made
- National implements new BP sign with additional security, and policies database completely updated in the process, numbers reduced once again
- London Police drop monitoring system for London's Block Parent Program
- Re-screening numbers drop significantly



What happened?

- Strategic Plan BPPCI
- · Risk Assessment by London Police
- London Police pulled financial support for police checks
- Updated Strategic Plan created for London Block Parent Program
- Civic funding model changed, granting process changed with it
- City of London denies grant to London Block Parent Program
- London Block Parent Program folds December 2016



 - Kids are driven to school







THREE LIONS Consulting

Time to Re-evaluate

- Around 2005 Strategic Plan changed to accommodate societal changes. Focused on diversifying funding sources, updating and delivering education programs, maintaining database of current Block Parents ensuring quality Block Parents, while quantity reduced and expand community partnerships
- 2010 Clean Air Grant from LCF obtained and Pilot Block Walk Program began in collaboration with Active & Safe Routes to school and MLHU
- 2011 ASRTS Committee deliver School Travel Planning concept piloted with huge success, support for Block Walk Program solidifies



Time to Re-evaluate

- After police removed monitoring service large percentage of resources went to rescreening efforts
- Quickly evident that numbers would gradually reduce, but survey indicated that there were many Londoners who wanted to continue.
- Strategic Plan in 2012 was to gradually allow the window sign program to reduce by attrition and simultaneously build Block Walk Program in schools across London and to diversify funding sources at the same time





Walking STATS

Since 1985, the proportion of Canadian children regularly walking to school has fallen by 50% to just 1 in 3.

26% of children & 33% of youth in London are overweight or obese



Only 52% of children and 30% of youth are active enough for optimal growth and development



Vehicle Trips to School

DO THE MATH FOR LONDON Elementary age only!



- Approx. 60,000 kids under 14 in London
- Estimated 24,000 families
- If 50% are driving their kids to school twice a day, assume 4km driven per day x 200 school days in a year = 800km per family x 24000 families

= 1,900,000 km's travelled per year

What is School Travel Planning?

- http://www.saferoutestoschool.ca/schooltravel-planning-toolkit
- A collaborative tool to assess barriers to walking to school.
- Uses assessment tools with the goal to identifying and creating an action plan to improve the walkability to school, to educate parents and children and encourage active transportation





Not walking/cycling alone:

- "Family Survey results indicate that 40% of parents and caregivers who do not usually allow their children to commute to school actively would allow their child to walk to school if they did not walk alone; 33% said the same about letting their child to cycle to school. Clearly, initiatives that address the issue of walking/cycling alone such as the Walking School Bus and Walking Buddies programs have the potential for big impact on the number of students whose parents allow them to use active transportation. In fact, 22% of parents and caregivers who reported driving less in the FollowUp Family Survey identified Walking Buddies initiatives and Walk to School Days as a highly effective STP activities
