 Protecting the health, safety and wellbeing of residents, care providers and neighbourhoods






PROCESS

Purpose of Amendment

- New categories of businesses
- Existing categories of businesses



Plan Moving Forward

- A public meeting each month at CPSC committee
- Jan through to May
- Review all in June and approve new by-law





Some Existing Categories

- · Public garages
- Eating establishments
- Adult entertainment locations
- Firework vendors
- Auctioneers
- · Hair salons
- · Tattoo parlours



Proposed New Categories

- Door-to-Door Sales Persons
- Payday Loan Lenders
- Pet Shops
- Donation Bin Operators
- Personal Service Establishments
- Tobacco Vendors
- Contractor Licensing



Payday Loan Lenders

Proposed Regulations

- 1)Post interest rate information
- 2) Maintain a referral list of debt counselling agencies available to clients
- 3)Zoning review done to ensure appropriate location





Pet Shops

Proposed Regulations

- 1)Limit the source of animals for retail sale to registered rescues, humane societies and animal shelters
- 2)Licence Manager to maintain a list of permitted animals
- 3) Prohibit the sale of animals at flea markets





Personal Service Establishments

- Already includes hair salons and body modification
- Consider adding nail salons, tanning salons and personal fitness locations

Proposed Regulations

- 1) Provincial age regs
- 2) Storage of chemicals
- 3) Health standards









Donation Bin Operators

Proposed Regulations

- 1)Permission of property owner
- 2)Standards around cleanliness and refuse control, with posted information
- 3)Metal bins only





Contractors

- Already includes mobile sign operators
- Consider adding driveway contractors and pool

Proposed Regulations

- 1) Requirement for written quotations
- 2) Compliance with municipal and provincial building regulations
- 3) Liability insurance
