# NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law. The requested changes are described below. We are advising you of this application to invite your comments.

## **APPLICANT:**

City of London

## LOCATION:

City-wide

# **PURPOSE AND EFFECT:**

The purpose and effect of the requested Zoning By-law amendment are to delete and replace, and/or establish new regulations for the purpose of making technical and housekeeping amendments to various sections of the City of London Zoning By-law No. Z.-1.

# **POSSIBLE AMENDMENT:**

Changes to Zoning By-law No. Z.-1 to permit the amendments to the following sections:

- Chapter 2 Definitions To add wording which ensures that 0.3 metres (1 foot)
   reserves function as an access control tool, rather than factoring into zoning regulations.
- Section 4.19 (10) (c) To ensure that accessible parking is required in a manner which is consistent with AODA regulations, and the Ontario Building Code.
- Chapter 2 Definition To refine the definition of "Frontage" to provide for flexibility in the location of parcel's front lot line.
- Chapter 5 & Chapter 6 To delete and replace regulations in order to clarify intent for conversions of existing structures.
- Section 4.14 & 4.19.4 To refine parking area setback regulations for specific uses throughout various Zones in the Zoning By-law, and to provide clarity with regard to parking requirements regulations as a result of land acquisition (expropriation/land dedication),

The application may result in consequential amendments to other sections in the Zoning Bylaw No. Z.-1.

#### PLANNING POLICIES:

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document.
