## **BACKGROUND**

The subject property is the portion of closed road allowance on the north side of Riverside Drive, abutting the property municipally known as 1185 Riverside Drive. The property was originally dedicated to the City by Plan 33M-189 to a distance of 18.0 metres from the centre line of the road, which is 5.0 metres more than the Z-1 Zoning bylaw currently requires.

The closed road allowance is not built out or travelled and the land is not required for public travel in the future. The road allowance was closed by City Council on March 2, 2017.

The closed road allowance at Riverside Drive has a site area of 303 square feet (28.18 m<sup>2</sup>) and contains a City sewer and telecommunications infrastructure.

### **Conclusion**

The property is surplus to the needs of the City and should therefore be declared surplus and sold in accordance with the City's sale and other disposition of land policy, subject to a sewer and utility easement over the entire parcel.
