BACKGROUND

Under the *Long-Term Care Homes Act, 2007*, (LTCH) every southern municipality that is an upper or single-tier municipality shall establish and maintain a municipal home. As a result, the Corporation of the City of London has established the Dearness Home and as Licensee, is holder of the license for service provision under the LTCH Act. The Licensee is responsible to ensure every requirement under the Act and Regulation is followed.

The *LTCH* Act also requires that the council of a municipality maintaining a long-term care home shall appoint from among its members a Committee of Management for the Home. The current Dearness Home Committee of Management was established under By-law No. A.-7204-2 on December 9, 2014 and includes five council members, and will meet a minimum of four times in each calendar year. Under the *LTCH* Act, the duties of the Committee of Management are to exercise the care, diligence and skill that a reasonably prudent person would exercise in

comparable circumstances and to take such measures as necessary to ensure that the corporation complies with all requirements of the Act.

In addition to its responsibilities under the *LTCH* Act, the Corporation as a long-term care service provider also has responsibility as a Health Service Provider (HSP) under the requirements of the *Local Health System Integration Act, 2006 (LHSI).* Under this Act, the Local Health Integration Network must have a service accountability agreement (SAA) in place with each Health Service Provider that it funds. The SAA for the long-term care sector is called the Long-Term Care Home Service Accountability Agreement (L-SAA). In April 05, 2016, Council approved a three year L-SAA agreement with the South West LHIN for the Dearness Home for the period April 1, 2016 to March 31, 2019.

Within the L-SAA is also the requirement that the "Board" authorize, by resolution, an individual to issue an annual Declaration of Compliance declaring that the HSP has complied with and fulfilled its obligations under the terms of the Agreement. Under Article 1.0 of the Agreement (Definitions and Interpretations), with respect to a municipality, "Board" means the Committee of Management.

At its meeting on February 22, 2017, the Dearness Home Committee of Management reviewed its requirements under the L-SAA, confirmed service compliance and authorized the Managing Director Housing, Social Services and Dearness Home to execute the Declaration of Compliance under the L-SAA for the period of January 1 to December 2016. A copy of the report to the Dearness Committee of Management and the Declaration of Compliance is attached as Appendix A. The Declaration has been forwarded to the South West LHIN. The Committee of Management also directed that a notice of completion of the Declaration be provided to the Licensee (Corporation) through this report to the CPSC committee.
