By-law No. A.-\_\_\_\_\_

A By-law to approve the Amending Agreement to the Purchase of Service Agreement for Ontario Works Employment Assistance Services.

WHEREAS subsection 5(3) of the *Municipal Act, 2001* S.O. 2001, c.25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS the template Agreement for the purchase of Ontario Works Employment Assistance Services was approved by By-law A.-6925-86 on March 5, 2013;

AND WHEREAS The Corporation of the City of London (the "City") entered into Ontario Works Employment Assistance Services Agreements with 13 organizations (the "Agreement");

AND WHEREAS the City and 12 of the organizations wish to extend the term of the Agreement for a further term (January 1, 2018 to December 31, 2018) by executing an amending agreement to extend the term ("Amending Agreement");

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The template Amending Agreement to be entered into between The Corporation of the City of London and each of the following twelve corporations:

- Collège Boréal (Collège Boréal d'arts appliqués et de technologie)
- Daya Counselling Centre
- Goodwill Industries, Ontario Great Lakes
- Hutton House Association for Adults with Disabilities
- LEADS Employment Services London Inc.
- Literacy Link South Central
- London Community Small Business Centre, Inc.
- March of Dimes Canada
- Nokee Kwe Occupational Skill Development Inc.
- Pathways Skill Development and Placement Centre
- WIL Counselling and Training for Employment
- Youth Opportunities Unlimited

attached as Schedule A to this by-law, is authorized and approved.

2. The name of the Service Provider shall be inserted into the template Amending Agreement approved under section 1 above for each of the twelve corporations set out in section 1 above.

3. The Mayor and City Clerk are authorized to execute the Agreements approved under Section 1 and as modified under Section 2.

4. This by-law shall come into force and effect on the day it is passed.

**WHEREAS** the Service Provider and the City entered into an Agreement effective January 1<sup>st</sup>, 2013, regarding the provision of Employment Assistance Services (the "Agreement");

**AND WHEREAS** the City and the Service Provider wish to extend the term of the Agreement for a further term (January 1, 2018 to December 31, 2018);

**NOW THEREFORE THIS AGREEMENT WITNESSES** that in consideration of the premises and the mutual covenants contained in the Agreement, and subject to the terms and conditions of this Amending Agreement, the parties agree as follows:

**1.0 AMENDMENTS**

1.1 Section 2.2 of the Agreement is hereby amended by allowing for a maximum of three one-year renewals. The parties agree to renew the Agreement for a further period of January 1, 2018 to December 31, 2018. The parties further agree that the Agreement will not be renewed beyond December 31, 2018.

**2.0 AGREEMENT BINDING**

2.1 Except as amended in accordance with the provisions of this Amending Agreement, the Agreement shall remain binding and in full force and effect.

2.2 This Amending Agreement shall be binding on the parties and their respective successors and assigns.

**3.0 EXECUTION**

3.1 The City and the Service Provider acknowledge that they have each read this Amending Agreement, understand it and agree to be bound by its terms and conditions.
