SUBJECT:	TENDER 12-21 REPLACEMENT OF SIDEWALKS, CURB & GUTTER AND HOT MIX ASPHALT

RECOMMENDATION

That on the recommendation of the Acting Executive Director, Planning, Environmental and Engineering Services and City Engineer, the following actions **BE TAKEN** with respect to the award of a contract for Tender 12-21; Replacement of Sidewalks, Curb & Gutter and Hot Mix Asphalt:

1. That the bid submitted by Coco Paving Inc., 1865 Clarke Road, London, Ontario N5X3Z6 at their tendered price of \$3,728,382.50, HST extra, , **BE ACCEPTED**, the bid submitted by Coco Paving Inc. was the lowest of five (5) bids and meets the City's specifications and requirements in all area;
2. That the funding for this purchase **BE APPROVED** as set out in the Source of Finance Report attached hereto as Appendix "A";
3. That Civic Administration **BE AUTHORIZED** to undertake all of the administrative acts that are necessary in connection with this contract; and
4. That approval hereby given **BE CONDITIONAL** upon the Corporation entering into formal contract or issuing a purchase order relating to these matters of this approval. (Tender 12-21)

BACKGROUND

Purpose:

This tender primarily supports the City's Annual Road Reconstruction Program (ARRP) which involves the reconstruction of secondary collector and local streets. The recommended award is based on the lowest tender received.

Discussion:

Tenders for the Replacement of Sidewalks, Curb & Gutter and Hot Mix Asphalt project were opened on March 15, 2012.

The ARRP is a unique program which uses a combination of City forces and the contractor to perform the works required for each individual street. This year 12 streets consisting of approximately 11.3 lane/km are proposed to be rehabilitated. Typically the City forces precede the contractor on each site to do removals and any sewer and watermain related works.

The recommended contractor, Coco Paving Inc. has performed numerous successful contracts for the City.

As noted on the Sources of Financing Report, Appendix "A" attached, a number of Capital accounts will be utilized to complete this project. The balance of funding in the approved Capital programs noted will be allocated to construction related projects through cost sharing arrangements with other Divisions and to City related expenses associated with these works and future works.

All tender submissions have been checked by the Construction Administration Division, Planning, Environmental & Engineering Services Department and are in order. Five (5) contractors submitted tenders as follows (exclusive of HST):

The tender estimate just prior to opening was \$4,085,000.00 (excluding H.S.T.).

All tenders include a contingency allowance of \$300,000.00 (excluding H.S.T.).

There are no anticipated additional operating costs associated with this work upon project completion.
