NOTICE OF APPLICATION TO AMEND THE ZONING BY-LAW

The Municipal Council for the City of London is considering an amendment to the City's Zoning By-law for the lands shown on the attached map. The requested change is described below. We are advising you of this application to invite your comments.

APPLICANT:

Rygar Corporation Inc.

LOCATION:

150 Dundas Street & 153 Carling Street - see attached map

PURPOSE AND EFFECT:

The purpose and effect of the requested Zoning By-law amendment is to permit a mixed-use development of 27 storeys with 600m² of ground floor commercial space and 200 residential units.

POSSIBLE AMENDMENT:

Change Zoning By-law Z.-1 from a holding Downtown Area (h-3*DA1*D350) Zone which permits a wide range of residential, commercial and retail uses, with a maximum density of 350 units per hectare, to a Bonus Downtown Area (B-()*DA1*D350) Zone which permits a wide range of residential, commercial and retail uses, a reduced residential tower setback, and an increased maximum density of 1,480 units per hectare in return for the provision of eligible bonusable facilities, services or matters outlines in section 19.4.4 of the Official Plan, such as enhanced urban design, increased universal accessibility, and the provision of public art.

PLANNING POLICIES:

Any change to the Zoning By-law must conform to the policies of the Official Plan, London's long-range planning document. These lands are currently designated as Downtown Area in the Official Plan, which permits a broad range of retail, service, commercial, office, residential entertainment, and institutional uses.

The subject lands are within the Downtown Place Type in *The London Plan*, which is intended to be the preeminent destination for culture, arts, recreation, entertainment, shopping and food, through the provision of a broad range of residential, retail, service, office, cultural, institutional, hospitality, entertainment, recreational and other related uses.

The written submissions, including names and contact information and the associated reports arising from the public participation process, will be made available to the public, including publishing on the City's website. Video recordings of the Public Participation Meeting may also be posted to the City of London's website. A neighbourhood or community association may exist in your area. If it reflects your views on this proposal, you may wish to select a representative of the association to submit comments on your behalf.

PUBLIC MEETING:

The appropriateness of the requested Zoning By-law amendment will be considered at a future meeting of the Planning & Environment Committee. You will receive another notice inviting you to attend this meeting.

If a person or public body does not make oral or written submissions at a public meeting or make written submissions to the City of London before the proposed amendment is adopted, the person or public body may not be entitled to appeal the decision of the Council of the City of London to the Ontario Municipal Board, or may not be added by the Board as a party to the hearing of an appeal unless, in the opinion of the Board, there are reasonable grounds to do so.

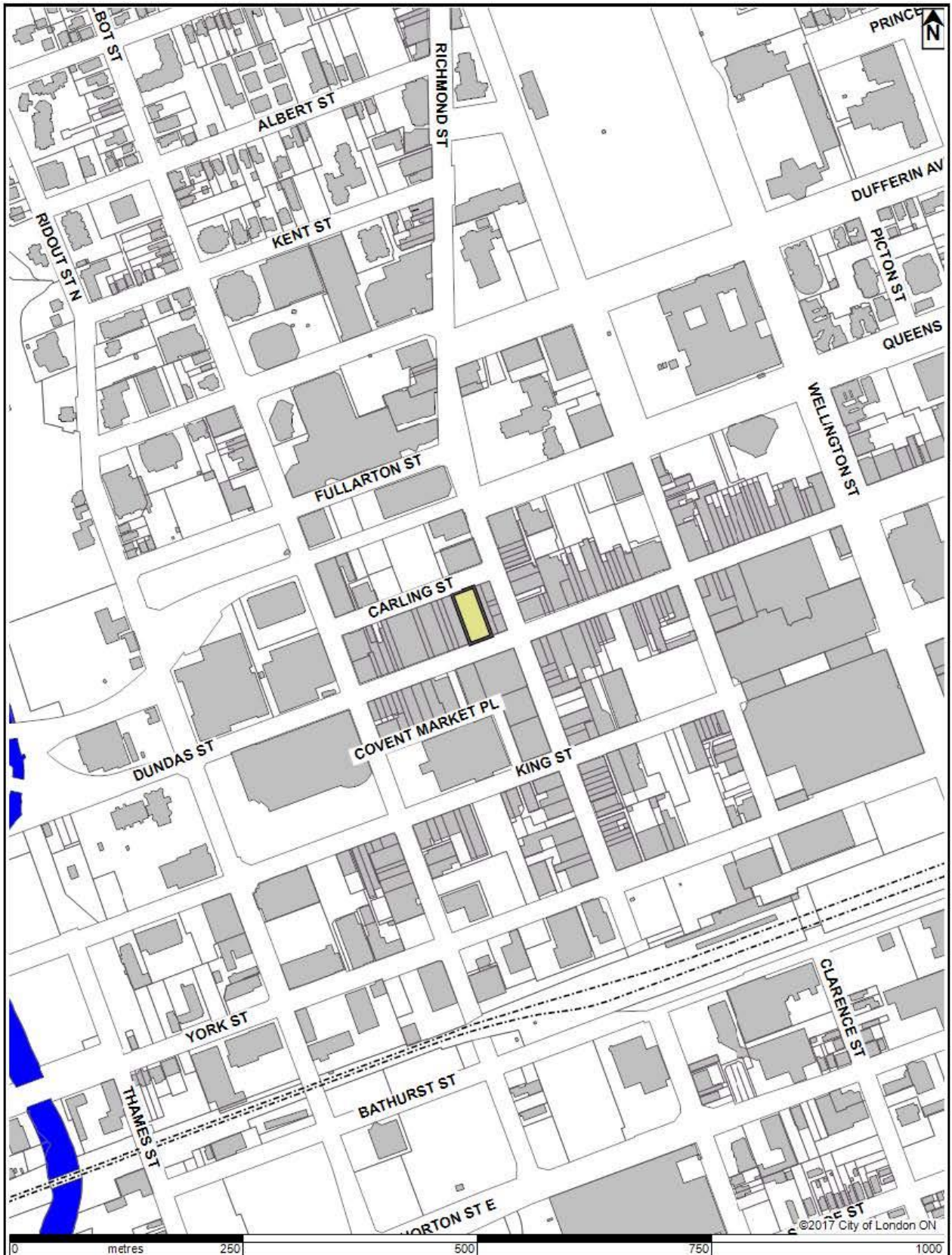
