By-law No. A.-_____

A by-law to repeal By-law A.-7490-16 and to appoint deputies to the City Clerk.

WHEREAS subsection 228(2) of the *Municipal Act, 2001*, S.O. 2000, c.25 permits a municipality to appoint deputy clerks who have all the powers and duties of the Clerk under the *Municipal Act, 2001* and any other Act;

AND WHEREAS subsection 228(4) of the said Act permits the Clerk to delegate in writing to any person, other than a member of Council, any of the Clerk's powers and duties under the said Act and any other Act;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. Linda M. Rowe is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
2. Evelina Skalski is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
3. Barb Westlake-Power is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
4. Sarah Corman is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
5. Julie Wilson is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
6. Domenic Anello is hereby appointed as a Deputy Clerk for the City of London under the *Municipal Act, 2001*, as amended, subject to the direction of the City Clerk, who shall have all of the powers of the City Clerk under the *Municipal Act, 2001* and any other Act.
7. By-law No. A.-7490-16 "A by-law to Appoint deputies to the City Clerk" enacted by the Municipal Council on December 19, 2016 is hereby repealed.
8. This by-law comes into force and effect on the day that it is passed.
