By-law No.

A by-law to amend By-law A-50 being a by-law to provide for the Rules of Order and Procedure for the Council of The Corporation of the City of London to change the start time for future regularly scheduled meetings of the Corporate Services Committee to 12:30 PM.

WHEREAS subsection 5(3) of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipal power shall be exercised by by-law;

AND WHEREAS section 9 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under this or any other Act;

AND WHEREAS the Municipal Council enacted the Council Procedure By-law (By-law No. A-50) on May 31, 2016 to provide for the rules of order and procedure for the Council of The Corporation of the City of London;

AND WHEREAS the Municipal Council wishes to amend the Council Procedure By-law (By-law No. A-50) to change the start time for future regularly scheduled meetings of the Corporate Services Committee to 12:30 PM;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. Section 26.1 " Meetings - regular – exception – holiday" is hereby amended in part (c) by deleting the time "12:00 PM" and by replacing it with the time "12:30 PM".
2. This by-law comes into force and effect on the day it is passed.
