#### 2015-19 STRATEGIC PLAN

The 2015 – 2019 Strategic Plan identifies the implementation and enhancement of road safety measures for all users as a means to deliver convenient and connected mobility choices.

### **BACKGROUND**

#### **Purpose**

The purpose of this report is to promote Canada's 15<sup>th</sup> annual Rail Safety Week, which is being held from April 24<sup>th</sup> to April 30<sup>th</sup> 2017. The purpose of Rail Safety Week is to raise rail safety awareness among all Canadians and to highlight the ongoing commitment of the rail industry and municipalities to make the rail network even safer.

#### Context

The City of London is serviced by a network of railway lines that move freight and passengers. The network is comprised of railways owned by Canadian National Railway (CN), Canadian Pacific Railway (CPR) and Goderich-Exeter Railway (GEXR), which account for over 60 at-grade crossings within the City. The railways are crucial to the economic prosperity of London and Southwestern Ontario as they provide a reliable and affordable way to transport goods and people.

The City of London can pride itself on taking proactive steps when it comes to rail crossing safety. In 2007, a safety review was completed by the City, Transport Canada (TC), CN, CPR, and GEXR which assessed all railway crossings in London. The safety review analyzed signage, pavement markings, vegetation, fencing and other issues. All recommended upgrades within City control were completed as a result of the review.

In 2013, the City of London undertook a Railway Pedestrian Safety Study. The objective of this study was to develop best practices for providing effective warnings to non-motorized users of road/rail grade crossings that inform the user of the presence of a crossing and suggest appropriate actions to prevent a collision. In November of 2013, Council approved the study and directed staff to liaise with the railway companies regarding opportunities to increase public awareness of rail safety issues.

In 2014, Council approved the London Road Safety Strategy (LRSS), which has a vision of safer road environments for all transportation users in London with a goal to reduce injury and fatal collisions by 10% over 5 years. The plan includes educational, engineering and enforcement actions as part of the strategy. The citizens of London and Middlesex County will benefit from the many road safety programs that will result from the London Road Safety Strategy. The vision of the Strategy is a path to a safer road environment for all transportation users in London.

In 2016, the City of London, in compliance with new Transport Canada Grade Crossing Regulations, worked with the rail companies undertaking critical safety information data collection at railway crossings to support crossing assessments. Currently, the City is undertaking the detailed safety assessments of the crossings required by the regulations to identify any deficiencies that exist and plan for upgrades with the railways.

Railway safety is a function of education, engineering, and enforcement. The City has been working with our railway partners to help promote education regarding railway safety.

#### DISCUSSION

## **Railway Safety Education**

Education is an important component in order to reduce/eliminate railway incidents. The Railway Association of Canada and Transport Canada operate the Operation Lifesaver (<a href="www.operationlifesaver.ca">www.operationlifesaver.ca</a>) program. Operation Lifesaver uses education, engineering and enforcement to prevent rail collisions and to prevent trespassing incidents that can lead to serious injury or death.

Every year in Canada approximately 240 collisions and trespassing incidents occur at highway/railway crossings and along railway tracks resulting in the death or serious injury of more than 100 people. Virtually all of these incidents could be avoided.

During Rail Safety Week, Operation Lifesaver volunteers engage in a number of local events and activities across Canada, including crossing blitzes, mock incident scenarios, public service announcements, and presentations by volunteers to schools, youth clubs, drivers associations, and community groups. The goal of educating people of all ages about the dangers of railway crossings and the seriousness of trespassing on railway property is mainly to prevent trespassing incidents that lead to serious injury or death.

## **Key Rail Safety Week Education Messages**

The following are key messages:

- Be aware, attentive and prepared to stop at highway/railway crossings.
- Listen for warning bells and/or whistles of an approaching train.
- Obey all signs and signals. Never attempt to drive under a gate as it is closing or around a closed gate. If the gate begins to close while you're underneath, keep moving ahead until you clear the crossing.
- Walking or playing on train tracks is dangerous and illegal. Railway property is private property.
- ➤ Playing on railway tracks and bridges is dangerous. Teach children to find safe, supervised and open areas (i.e. neighborhood parks) to have fun.
- > The only way to cross railway tracks is to use designated railway crossings.
- If children must cross railways, for example on their way to and from school, teach them to stop, look, and listen before crossing railway tracks.
- > It is against the law to trespass on railway property.
