
#### **DISCUSSION**

The survey asked three questions, the responses of which are provided below. Any comments that were provided outside the online survey are summarized in Appendix 'A' attached to this report. There were 815 online responses received between March 10, 2017 and April 26, 2017. There were also paper surveys completed at the open houses and Councillor-lead community meetings. It should be noted that not all questions would have necessarily been answered in all of the survey responses.

Somewhat Confident: 91



## CONCLUSION

In accordance with Section 41.2(1) of the *Municipal Elections Act*, 1996, if Municipal Council were to decide to implement a ranked ballot election for the 2018 municipal election, a by-law must be passed on or before **May 1**, 2017 in order to allow the Civic Administration to implement the change. A proposed by-law to implement a ranked ballot process, should Municipal Council choose to implement this process in the 2018 Municipal Election, has been attached as Appendix 'B" to this report..

#### Additional Comments:

I don't know if I could remember, well, especially when there is the potential for similar names to appear on the list.

ONLY POLITICIANS WHO ARE NOT GOING TO GET RE-ELECTED IN OUR NEXT MUNICIPAL ELECTION ARE IN FAVOUR OF THIS RIDICULOUS NOTION OF RANKED VOTES

More waste of money by this council.

I believe going to a ranked ballot system will result in less Londoners voting or result in spoiled ballots.

History would clearly demonstrate how difficult it is to get people out to the polls to vote for single candidates, so to add this ranked ballot concept would likely overwhelm the average voter. Terrible idea!!!!

Unfortunately, my experience since living in London is that there are seldom 2 or 3 candidates worth my vote. I would hate to think that some might pick a 2nd or 3rd choice because they think they have to. I understand a voter still has option of voting for 1 candidate, thus does not have to rank 2 or 3. I am not sure ranked ballots will increase voter turnout, but if the voter is going to rank 3 candidates, the voter will likely pay more attention to those candidates running, not just an incumbent that has the popular support by name recognition.

Based on the Corporate Services report, it would be foolish for us to push forward with ranked balloting for the 2018 election. Too many issues remain unresolved (software and hardware) to allow us to proceed at this time.

The candidates' names on your list are so appropriate!

I don't believe ranked ballots are constitutionally fair to the voter. I don't want to place any endorsement for a candidate that I don't want to vote for.

I think that this needlessly complicates the electoral system. It is never easy trying to find out where the candidates stand on the issues. To ask the average voter to rank three in his ward would be asking a lot. Instead the voters may just end up randomly picking a candidate for their second or third choice.

Name recognition is very important. This system may favor the incumbant if the voter selects that candidate as one of their choices just because they heard of them.

This is a much fairer method of choosing the best candidate. Lets get moving with this NOW. Why does our present council defer so many issues and waste time on discussing the same issues for months. If I ran my business this way I would have closed the doors years ago.

We feel that the proposed Ranked Choice Ballot process is somewhat complicated and unwieldy. More information and further explanation is required. We are not certain that this process would necessarily be an improvement over the First-Past-the-Post system we are all so familiar with.

A computerized form of registering ballots sounds attractive in that it would eliminate the necessity of manual vote counting. This we feel would be of benefit.

It is wrong to rush a decision for the 2018 municipal election. If this goes through it will because of the will of council, not the people. This will make it easier for future councils to change how they are elected. Do better.

No need to change... Just a make work project by those trying to find a way to increase their political influence beyond their numbers.

Huge time and effort saver here. For everyone. Might take a little longer to sort and count, but sometimes that's the cost of effective choice. Eliminates the best of the worst types of choices.

No longer a belief in defacing ballots because there's no "no e of the above" option. There are multiple ways this gives more power and means to express it back to the voting public. I really don't see a downside.

-focussing on one candidate and their key strengths

I would prefer a change but do not feel there is adequate public support to justify a change. This is a significant step requiring broad buy-in. Also, I am not confident we have the technology to count these ballots in a way that will not embarrass us as a community. Once we know the public is solidly behind this idea, and once we know we can do a credible job of counting and reporting results, then let's make the change. Thanks for asking.

It would be nice to see a candidate win with 50% + 1 vote of votes cast. Long overdue!

Seniors tend to vote. I believe changing the way we vote would cause unnessasary confusion on voting day. A change in the way we vote may be enough of a deterrent to convince senior voters and others to stay home and not vote at all.

Also, we can't afford to spend more tax payers money at this time. Council has enough on their plates that they are having trouble dealing with without adding another unnecessary item.

The present system works fine.

I believe that first past the post-balloting is outdated.

In my opinion, if you don't have a majority of Londoners (51% ++) in favour of a ranked ballot system it should not be changed.

What is the rush to be first? This is a subject that can be revisited at a later date without pressing up against a deadline as it is now.

The ranked ballot is more democratic and inclusive than the first past the post process. It may allow for a more diverse pool of candidates, and the winner will have more legitimacy as the choice of more than half of voters.

Is it possible to vote for the candidate you want 1 2 and 3 in the event you did not like any of the others on the ballot? The reason being that if the candidate did not make it on the 1st ballot he/she might make it on the second or 3rd ballot.

Waste of tax dollars on this as an issue.

Federal level - makes sense.

3rd choice wins mayor in my city - this happens naturally now.

Ranked ballot electoral system is long overdue.....go for it!

Ranked ballots can be manipulated. I lived in Chatham for many years. They didn't have a "ward system". We had seven aldermen positions city wide. Each eligible citizen could vote for up to seven of those who were running for the job. It could be manipulated to get a person elected simply by having the backers or certain demographic groups vote for just one person and deny any votes for the remaining six positions. I had no confidence in that system nor in a ranked ballot system.

Surely "Ranked Ballots" is far more democratic than "First Past the Post" No Polical Party uses "First Past Post" internally when choosing candidates / leaders. Ranked Ballots will mean a councillor will not get elected wit say 26% of vote as happens

Throughout Ontario.

Ranked ballot system long overdue for the next municipal election. Nice to see a candidate win with 50% plus 1 vote.

Of course your first question should say "being able to choose up to three" You can vote for one, two or three candidates.

Too confusing and people won't take the time to understand.

This is not a good idea. This will cause major confusion at the polls. Despite the city pushing this on Londoners, the change is not warranted. Rather than these one sided "consultations" the proposed change should be the subject of a referendum on next Election Day.

Having a candidate elected by 50% of the votes cast would mean the right candidate got elected......better than first past the post method!

seems to be a much fairer system, both to the voters and the candidates. Kudos to London for taking this major step forward!

50% + 1 = 49.9% unhappy voters. Shouldn't a winner have a clear majority, say 65 or 70 % ? What about a referendum type system ranking the issues Londoners want dealt with then choose the person to implement it. There also needs to be some mechanism to remove incompetent people before their "due date". (ex - Premier Wynne). Isn't the idea to have someone who represents what the constituents want done, not their personal feelings or pet cause?

The Ranked Choice Ballot looks far too confusing. First Past the Post is the simplest and most effective tool for voting. As for touch screen voting, have you learned nothing from the Americans? Pencil and paper is the safest and easiest way to vote.

It's a red herring for some to say "it's too complicated." People will very surely learn how it works quickly and easily so we should go ahead.

this worked well in the Federal Liberal leadership vote so it should be great at the municipal level as well

This makes so much sense!

I firmly believe that a ranked choice ballot allows voters to better participate in democratically selecting our elected officials. This alternative limits strategic voting and ensures that every vote counts in an election. There are countless benefits to adopting a ranked choice ballot, with few drawbacks beyond a delay in result tabulation, the need for an educational campaign, and increased costs in administering the election. There is no argument that such a system makes an election \*less\* democratic, but can only operate to better reflect the views of a greater majority of people and elected candidates who are most desired by a wider section of the electorate. I think that London should be an industry leader in making this progressive change and be a trailblazer in the move to a new democracy for our country. That being said, I also think that a change like this needs to be done right. There is no use in pushing a new system through in an unrealistic timeline that may lead to an ineffective or criticized election. Proper time for studying and acquiring necessary election infrastructure as well as time for a thorough and effective informational campaign must be respected. So we should be a leader in electoral reform, but be a successful one.

This will be an amazing change for London. More people of diverse backgrounds would consider running if this happens, which is exactly what London needs to aim for.

I'm not sure why the City of London is considering changing its voting practices for municipal elections. As I understand it, no other city in Canada has adopted a Ranked Choice Ballot system and I'd don't think that London should be the first. There will be considerable extra costs associated with setting up this new system (equipment costs, promotion of the new system, etc) which I don't believe will help Londoners vote. I prefer the current First-Past-the-Post Ballot system which is clear, straightforward, and has no additional costs associated with it. I want to cast my vote for the candidate of my choice, and a Ranked Choice Ballot has the potential of letting candidates "win" that I don't fully support

I think that City Council should drop consideration of this initiative and concentrate on thinking of ways to get more Londoners out to vote on election day. To me, that's a far more important, worthy issue to look at (and likely a lot less expensive!).

Ranked ballots is great - fairer representation, and it leads to less ugly, negative campaigning (because each candidate wants to avoid alienating supporters of other candidates, in hopes of being their second choice pick)

Why one vs 3? Why not 2 or 4 or other? What if there are only 2 candidates? I am infavour of the concept but not the potential implementation if this survey is any thing to go by!

Before you try to make elections more 'fair' or 'equitable' please read the book Democracy for Realists.

Having worked many municipal elections the motto should be keep it simple stupid! It's hard enough to get people out to vote. Let's not make it anymore difficult for them or for the folks who work the elections!! This is a crazy idea.

I believe this would allow for the best candidate to be chosen in a more thoughtful and equitable manner.

Ranked choice allows fringe candidates to skew the vote.

the current Mayor and council are a bunch of scumbags I attended the highly screwed pro ranked ballot public participation meeting held Saturday April 22nd. I sat and listened to the staff presentation and the comments made by the pro ranked ballot supporters. I do not believe ranked ballots are a better voting method than first past the post. The candidate with the most votes should win. I believe my vote counts even if my candidate does not win. There are winners and losers in elections. As for candidates not running because they do not want to split the vote or they do not feel they could win in the current first past the post system, those ideologies are just sad. You run in an election because you believe you are the best candidate for the job. I vote for the person who I believe reflects my views of the current issues of the day, regardless of their gender or if they were a visible minority. How can you go ahead with ranked ballots when you don't know the actual costs of implementing this process? According to city staff there are no known vendors that currently have the algorithm that complies with the Ontario Governments requirements for ranked ballot elections. Valuable time must be spent finding a vendor, negotiating a contract to develop, test and support this algorithm. Time will also be required by city staff to certify that the algorithm works before the next election. Time and money will also have to be spent educating the citizens of London on how ranked balloting works. According to city staff once city council has committed to ranked ballots if problems arise in this process there is no going back to first past the post without going back through the public engagement process. It was mentioned at Saturday's meeting that the 2018 election could be used as a pilot for ranked ballots how ridiculous is that notion. Once you have spent the time and money converting to ranked ballots it is unlikely to revert back to first past the post.

It is my opinion that this group of pro ranked ballot citizens do not speak for all citizens of London. There are 383,822 citizens in London and based on the number of people that have attended the various ranked ballots meetings and have been engaged in the various other platforms, my guess is that only a small minority of the total are in favour of ranked ballots.

I do not believe this council has the mandate to change our democratic process of voting without fully engaging all citizens of London. Listen to the staff recommendation on this one do not change our voting process for 2018. Council has rushed the public participation process in this issue. Londoners do not fully engage on an issue until it impacts them. Prime example BRT. Look at how many years the city has been working on LRT/BRT before the people of London became engaged in the process. They did not become engaged until they learned about the tunnel and how BRT was going to impact them. The decision to change to a ranked ballot electoral system is too important and should not be made without fully engaging the entire population, let the people decide, put it on the ballot as a referendum. Spend the time between now and the next election informing the public on how ranked ballots work. If you are so compassionate about ranked ballots openly run with ranked ballots as part of our campaign platform. Go to the people knock on doors go to the malls to discuss this issue, don't assume the people will come to you.

In real estate it is location, location, location, in politics it should be communication, communication, communication. Learn from the communication mistakes that have been made with BRT and don't repeat them.

I don't think a majority of councilors (7 or 8) have the right to change our voting system that has been in place for over 100 years. Most of them never indicated their preference for this when they were campaigning for election.

Make it an issue for the next election - put a question on the ballot and let Londoners decide how they want to vote, not just a few people.

We have more important issues to address like the Richmond overpass and the Adelaide underpass and a ring road. Lets stop talking about Rapid Transit and Ranked Ballots and look at priorities.

Lets stick to priorities.

Why waste our tax dollars on unnecessary things, we need to over passes 1 on Richmond and 1 on Adelaide and we need a another round about to connect the out skirts of the city with out having to go through it.

Come on people, this is not a high school prom where we need to spend money on prom kings and queens. A school teacher is using high school tactics to run a city, this is quite pathetic.

There is no need, emotional or otherwise, to have my opinion recorded for who I would like to place second or third in an election.

My hope will be that the person I believe to be deserving is the person who wins through the most votes.

Period.

The 3 questions address the issue well enough.

I don't need three choices. I prefer to research well and vote for the one person I decide on win or lose the most votes should suffice. I believe the currant method works well and will be quicker, less confusing for some.

#### Appendix 'B'

#### **By-law Authorizing Ranked Balloting**

Bill No. 2017

By-law No. E .-

A by-law with respect to ranked ballot for the 2018 municipal election.

WHEREAS subsection 41.1(1) of the *Municipal Elections Act, 1996*, as amended, provides that the Lieutenant Governor in Council may, by regulation, authorize elections for offices on a municipal council to be conducted in accordance with the following rules: 1. Electors vote by ranking candidates for an office in order of the elector's preference. 2. Votes are distributed to candidates based on the rankings marked on the ballots. 3. The counting of votes is carried out in one or more rounds, with at least one candidate being elected or eliminated in each round.

AND WHEREAS subsection 2(1) of Ontario Regulation 310/16, made under section 41.1(1) of the *Municipal Elections Act*, authorizes ranked ballot elections for offices on the council to be conducted.

AND WHEREAS subsection 41.2(1) of the *Municipal Elections Act*, 1996, as amended, provides that the council of a local municipality may pass a by-law with respect to ranked ballot elections for offices on the council if such elections are authorized by a regulation made under section 41.1.

AND WHEREAS subsection 5(1) of Ontario Regulation 310/16, made under section 41.2(3) of the *Municipal Elections Act, 1996*, as amended, requires that before passing a by-law respecting ranked ballots, Council must consider: 1. The costs to the municipality of conducting the elections; 2. The availability of technology, such as voting equipment and vote-counting equipment and software, for conducting elections; and 3. The impact of the proposed by-law would have on election administration .

AND WHEREAS Council has considered the requirements set out in subsection 5(1) of Ontario Regulation 310/16.

AND WHEREAS, sections 10 and 11 of Ontario Regulation 310/16, made under section 41.2(2) of the *Municipal Elections Act, 1996*, as amended, require that an open house and a public meeting be held with respect to the proposed by-law to allow the public to review information, ask questions and make representations.

AND WHEREAS open houses were held on March 8, 2017 and March 9, 2017, and a public meeting was held on April 22, 2017, in accordance with sections 10 and 11 of Ontario Regulation 310/16.

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

- 1. Ranked ballot elections shall be used for all offices on the council for The Corporation of the City of London.
- 2. An elector is entitled to rank a maximum of three (3) candidates for the office of Mayor and three (3) candidates for the office of Ward Councillor.
- 3. This by-law applies to all regular elections and by-elections of The Corporation of the City of London.
- 4. This by-law comes into force and effect in accordance with section 8 of Ontario Regulation 310/16.
