If there is any way we could sneak onto the next agenda it might make all the difference. If its not possible, is there any way to go directly for consideration at the May 16th Council Meeting? We'd certainly take the May 23rd meeting if that is the only option left.

Appleseed Cider Festival is a celebration of Ontario Craft Cider products and is part of a provincial tour promoting ciders that is an extension of Ontario Craft Cider Week.

The date of the event is Saturday, June 24th from 3:00 - 11:00 pm. The location is Hassan Law Gallery (142 Dundas St.) and an adjacent street closure of Dundas street.

We have applied for the street closure, but intend to do the event solely on the private grounds of Hassan Law Gallery in the event the application is denied. Please see our map for full details related to the proposed site plan. The outdoor portions of the event will be fenced by barriers of the required height. We will be reaching out to the appropriate City departments (Parks & Recreation, Police, Fire, Health Unit) to inform them of our plans and to confirm use of this additional space.

We are asking council for a designation of Municipal Significance for this event in order for it to be properly licensed with the AGCO.
