By-law No. S.-_____

A by-law to lay out, constitute, establish and assume lands in the City of London as public highway. (as widening to Sarnia Road from Wonderland Road North to Sleightholme Avenue)

WHEREAS it is expedient to establish the lands hereinafter described as public highway;

NOW THEREFORE the Municipal Council of The Corporation of the City of London enacts as follows:

1. The lands and premises hereinafter described are laid out, constituted, established and assumed as public highway as widening to Sarnia Road from Wonderland Road North to Sleightholme Avenue, namely:

“Part of Block “I” on Registered Plan 966, in the City of London and County of Middlesex designated as Part 1 on Reference Plan 33R-18855.

Part of Block “G” on Registered Plan 966, in the City of London and County of Middlesex designated as Part 2 on Reference Plan 33R-18855.
