1. Research: 111 Clarence Street — designation request withdrawal

The LACH Stewardship Sub-Committee discussed implications of the withdrawal for designation (by Catherine Morrisey) on research already undertaken for this property. Committee members did not want to loose momentum or have the research that's been accomplished — lost. Members agreed that they would like to invite the new property owner to consider designation, and at that time, if there is a positive response, the committee would continue to move forward with research with the goal of eventual designation of the property. More discussion is needed on this subject when more members are present.

In lieu of 111 Clarence Street, the Stewardship Sub-Committee discussed several other properties to begin researching for potential designation purposes.

2. Research Consideration: 220 Greenwood Avenue

The Stewardship Sub-Committee reviewed status and attributes of 220 Greenwood Avenue and concluded that it could be a significant heritage property and is worthy of further research.

- Listed property on City Register; c1860/1870 side-gabled cottage
- Some urgency to complete research within the next month due to a recent site plan consultation with application involving the tear-down heritage property and rebuilding on this site
- Project research leader and heritage staff coordinator (J. Cushing and K. Gonyou, respectively)
 - M. Whalley to explore architectural significance; J. Hunten to explore city directories; J. Cushing to explore occupancy; A. Beaton to photograph
 - ➤ To complete draft of Evaluation of Cultural Heritage Value or Interest by next meeting May 31st

3. Research Consideration: 1424 Clarke Road

The Stewardship Sub-Committee once again reviewed the status and attributes of 1424 Clarke Road and concluded that it could be a significant heritage property and is worthy of further research.

- It is a listed property on City Register; 1870s vintage w/ possible 1840s
 kitchen wing; centre gable farm house with gothic windows at the upper storey and emphasized brick quoins at the corners of the main house
- Upper Thames reviewing current state of property
- Project research leader and heritage staff coordinator (M. Whalley? and L. Dent, respectively)
 - ➤ M. Whalley to explore architectural significance; T. Regnier to explore cultural significance and mapping; A. Beaton to photograph
