SUBJECT	TS1325 - VETERANS MEMORIAL PARKWAY SOUTH EXTENSION ENVIRONMENTAL ASSESSMENT CONSULTANT ASSIGNMENT SCOPE CHANGE

RECOMMENDATION

That, on the recommendation of the Acting Executive Director, Planning, Environmental & Engineering Services & City Engineer, the following actions **BE TAKEN** with respect to the approval of additional engineering fees for the Veterans Memorial Parkway South Extension Environmental Assessment Study (TS1325) to increase the scope of work to include preliminary design:

- the value of the McCormick Rankin Corporation assignment for the environmental assessment **BE INCREASED** by \$316,292 to \$606,142 (excluding HST) for the said project; it being noted that the Ontario Ministry of Transportation is committed to funding 100% of this cost increase; and,
- (b) the financing for this project **BE APPROVED** as set out in the Sources of Financing Report <u>attached</u> hereto as Appendix "A".

BACKGROUND


Purpose:

This report seeks the approval of Municipal Council to expand the Veterans Memorial Parkway South Extension existing consulting assignment to now include Provincial EA and additional preliminary design. This project would now become a partnership with the Ministry of Transportation (MTO) and be advanced on an expedited schedule up to the point where a potential design-build contract can be let.

Discussion:

On April 4, 2011, the Municipal Council resolved that "the Civic Administration BE REQUESTED to commence an environmental assessment for the extension of Veterans Memorial Parkway south to Wilton Grove Road, in order to prepare for future development opportunities in that area, and to liaise with the Province with respect to potential financial contributions". Staff subsequently commenced the environmental assessment using the services of McCormick Rankin Corporation. The consultant was acquired through a competitive consultant acquisition process during which the Ministry of Transportation (MTO) was engaged to ensure that the selected consultant met provincial requirements for design work on freeways.

The south extension of Veterans Memorial Parkway along with a new interchange at Highway 401 and Wonderland Road are included in the London Economic Development Plan options and are supported by the draft Industrial Land Development Strategy Update recommendations. Provincial government support for these projects was provided in a letter from Kathleen Wynne, then Minister of Transportation, in August 2011. A multi-phase project has been added to the provincial government 2011 to 2015 Southern Ontario Highways Program. This was a very significant action by the province; it makes them provincial projects with an objective to



complete in the next five years. Discussions with MTO staff have since progressed on how to expedite the projects while working towards a cost sharing agreement.

MTO intends to complete the project within the next 5 years as the project lead with the City as a project partner. The ministry has recommended an increase in the scope of the current assignment to satisfy the provincial class EA process and to accelerate the project schedule by adding an additional preliminary design phase to prepare for a design-build tender. MTO has committed to funding the additional consulting fees for the enhanced scope of services in recognition of the City funding the original consulting assignment. A final cost sharing agreement for the project is to follow. The project involves a 1 km extension of the VMP to Wilton Grove Road and a reconfiguration and expansion of the VMP interchange at Hwy 401. The additional services to be provided under this scope change are:

- 1. Highway Engineering additional scope of design, stormwater management, staging analysis, property impacts, utility relocations and construction scheduling;
- 2. Environmental Stage 2 archaeology investigation, preliminary contamination screening, hydrogeological assessment, additional natural environment reviews and assessment for MNR consultation, and additional geomorphology stability assessment;
- 3. Electrical Engineering illumination warrant analysis and partial design of interchange lighting; and,
- 4. Bridge Engineering increased analysis of design alternatives and construction staging and the preparation of a Structural Design Report.

The additional fees include a 10% contingency in the event of unforeseen requirements and a provisional item for additional electrical design in the event full freeway lighting is warranted.

Provision of these services by McCormick Rankin under the current assignment will accelerate the project schedule by integrating the additional design phase with the EA and reducing the time required to advance to a design-build tender.

Conclusions:

The Environmental Assessment for the extension of Veterans Memorial Parkway to Wilton Grove Road is underway. Since the commencement of the consulting assignment last April, MTO has announced this project as a Provincial initiative within their 5 year Southern Highways Program. The ministry has recommended an expansion of the consulting assignment scope. This expanded scope includes additional design services to satisfy the provincial class EA process and advance the project to a design-build tender status.

The previous assignment was valued at \$289,850. The additional services increase the cost of the consultant assignment by \$316,292 to a new total of \$606,142 (excluding HST). MTO has committed to funding these additional services.

RE: Veterans Memorial Parkway South Extension – Preliminary Design Study

MTO recognizes The City of London's desire to advance the Preliminary Design (PD) and Environmental Assessment (EA) to expand the Highway 401 / Veterans Memorial Parkway (VMP) interchange and extend the Parkway southerly from Highway 401 to Wilton Grove.

In recognizing that the City of London will be responsible for initial costs of \$ 289,850.00 when the PD/EA was awarded to McCormick Rankin Corporation, MTO has agreed to advance funding for the additional work undertaken by MRC to complete the Preliminary Design to a 30% Detailed Design level and to meet Provincial EA requirements for the reconfigured VMP / Highway 401 interchange. The cost of this additional work is \$316,292.00. Any future additional costs would be addressed separately. Both the city's and the ministry's consultant costs will be revisited as part of future cost-sharing discussions.

Advancing the project design to a 30% detailed design level allows flexibility for the City and MTO to consider a Design Build delivery model for construction.

We look forward to working with you on this project.
