- Obliterated serial numbers
- Obtaining goods from youth
- Under the influence of drugs or alcohol
- Police record checks
- Verify identity ( not recorded)
- Record all transactions
- Submission of records to Police
- Focus on BnE items
- Submission of photos to Police
- Hold period – five days

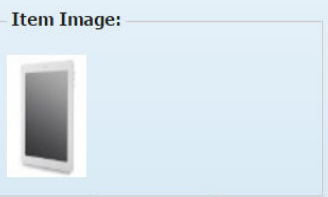
